Above Left Photo: Compatriot Carold Bland (center) gave the program today on his experiences as a combat veteran in Europe during WW II. He served three years as gunner and radio operator as part of a four-man team in a light tank in the 12th Armored Division, which was part of General Patton's Third Army. The Hellcats, as Carold's 12th Armored Division was known, fought their way across western France, on across the Rhine River and through Germany, engaging in fierce fighting along the way. In one pitched battle, engaged to protect a critical bridge, 77 light U.S. tanks were destroyed by withering Nazi fire, and many good patriotic men lost their lives. However, the allies prevailed and the bridge was saved allowing rapid advance to continue. The Hellcats were feared and respected by the enemy for their aggressive fighting. By late in the war, his unit had reached deep into Germany and liberated eleven German death camps, two of which Carold witnessed. He saw horrific human condition and misery of the prisoners at those camps that no words can adequately describe. Program: "New Harmonies: Celebrating American Roots Music" Exhibition

Debra "Debi" Boughton, Kirksville Chamber of Commerce tourism director, spoke about this Smithsonian Institution exhibition which will debut in Kirksville, the first

in the state, before being shown serially in five other small cities during the year. The exhibit, sponsored by the Kirksville Arts Association and the Adair County Historical Society, will be at the Kirksville Arts Center, 117 South Franklin, Kirksville, from March 21 - May 2, 2009.

In addition to the many exhibits supplied by the Smithsonian, there will be exhibits supplied locally of musical instruments, sheet music, recordings and information on noted performers from this area.

Numerous events are planned in conjunction with the exhibition. There is an opening reception scheduled for March 20, 5-7 p.m. at the Kirksville Arts Center. A dozen musical events, workshop, and speaking engagements and five "Lunch and Learn" events will follow. After the exhibition leaves, there will be a concert by Rhonda Vincent and the Rage Sunday, May 3, at 2 p.m. at Rotary Park amphitheater (rain site: TSU Baldwin Hall). There will be no admission charged for the exhibition or events, except the "lunch and learn" series (\$10 each or 5/\$45).

The Arts Association is looking for volunteers to help staff the exhibit during its run to serve as docents as well as to provide security for the materials exhibited.

TODAY'S PROGRAM: CAROLD BLAND AS HIS REVOLUTIONARY WAR ANCESTOR

Carold Bland assumed the role of his Revolutionary War Soldier ancestor, Ezekiel Billington, complete with uniform, powder horn, haversack and wooden canteen. (In right photo, Compatriot Bland is pictured with Club President Gary Lloyd. Photo below shows soldier's equipment.)

Ezekiel enlisted in the Militia in Newark, New Jersey. After enduring several battles and the hardships associated with the underfed and under-clothed soldiers of the times, he was captured by the British. They held along with several other captured soldiers in a sugar house with no windows, under very crowded conditions and with no toilet facilities. As his compatriot prisoners died one by one, he volunteered for burial duty to get out into the fresh air. Eventually, he was faced with the choice of either joining the British Army or die. He chose the former and made plans to escape when he had a chance. After one of his friends, whom he thought was trustworthy, revealed his plan, he was wounded badly enough that he escaped execution. He was sent to the West Indies and eventually made his escape then went on to serve with the Continental Army for several more years. After five years of heroic service, he was finally discharged, after the war was winding down.

TODAY'S PROGRAM: GENE SCHNEIDER ON "THE BATTLE OF KIRKSVILLE"

Gene Schneider spoke on the Battle of Kirksville fought on August 6, 1862, and the events leading up to it as well as its aftermath. He explained why the Union under Col. John McNeil won the battle in spite of far superior Confederate numbers led by Col. Joseph Porter. The Confederate troops were mostly freshly recruited farm boys that had had little to no military training with more than half unarmed. Porter had been recruiting men in northeast Missouri to take to Arkansas for military training. The aftermath was that the Confederates were unable to conduct large scale recruiting efforts in the area. After the battle, McNeil ordered the previously execution of several captured Confederates for having violated their oath to never fight the Union army again.

NEW MEETING TIME BEGINNING IN SEPTEMBER

PROGRAM: PRESIDENT GARY LLOYD ON THE TWO REVOLUTIONARY WAR SOLDIERS BURIED IN ADAIR COUNTY, THOMAS LAY AND JAMES FLETCHER

Patriot Lay of North Carolina enlisted in the North Carolina State Troops for one year in 1780 and engaged is several skirmishes against the Tories. He later moved first to Claiborne County then Grainger County, Tennessee before moving on in 1843 to the Morrow township area of Adair County, Missouri. Patriot Lay, born in 1763, died between December 23, 1844 and March 4, 1845 and was buried in the Collett Cemetery near the first white settlement in Adair County. Patriotic citizens erected a monument there in his honor on October 10, 1890.

Patriot Fletcher of Virginia first enlisted in the Virginia State Troops in 1777 and then served two full three-month terms one year apart and later part of a third. He participated in no battles but did capture a deserter from the Continental Army whom he delivered to the recruiting post at Winchester, Virginia, 70 miles away. Fletcher later moved to North Carolina then to Hart County, Kentucky before moving on to Randolph County, Missouri in 1830. By 1840 he had moved to a site that became a part of Adair County when it was formed in 1841. Fletcher was buried in what is now an isolated area, one-half mile from the nearest road, one mile east of Yarrow on a wooded hill owned by Ron Weber. At the time, there was probably a cabin there where, in 1840, he had been living with the family of his son, Elias Fletcher. A monument was erected in his honor there on August 30, 1892, by the G.A.R. with a great celebration attended by almost 1,000 people. The monument is inscribed: "James Fletcher, A Revolutionary War Soldier, Born April 29, 1758. Died Sept. 27, 1845. Rest Soldier Rest. Thy Warfare's o'er". [Since 1966, it has been widely reported that a third such Revolutionary War patriot was buried in Adair County by the name of Thomas Fletcher who was said to be a brother of the aforesaid Patriot James Fletcher and buried near him. However, no evidence has been found to support that contention.]

DR. MARK HANLEY ON GEORGE WASHINGTON

Dr. Mark Hanley (left), professor of history at TSU, spoke today about why he ranks George Washington as the best president the nation has ever produced. He said that in any presidential rankings by historians, Washington, Lincoln and Roosevelt are always within the top three, but Lincoln is sometimes listed first. Dr. Hanley said that although there were many outstanding leaders that founded the country, he cannot imagine anyone but Washington who could have brought and kept all those men together long enough to found and preside over a new country

that was unlike any that existed before. While Washington was not an intellectual like Jefferson, Madison, Hamilton and others, he was a very wise man who got the major decisions right. His integrity was beyond reproach, he was brave in battle and his appearance commanded tremendous respect by all. In the talks and negotiations throughout the founding process, he stayed above the fray, making him an acceptable leader to all. He was, of course, a man and therefore imperfect (he had a bad temper, and perhaps pondered issues to an unnecessary depth). Washington appointed some members of his cabinet who were bitter enemies, such as Adams and Jefferson, because he wanted to hear all sides of an issue before making a decision. That was also practiced by another great president, Abraham Lincoln. The speaker is pictured with SAR Chapter President Gary G. Lloyd.

PROGRAM: HISTORY OF ADAIR COUNTY

Gene Schneider (right) spoke to us today on the history of Adair County. His talk addressed its main events starting with the first white settlement in 1828 on what was to later become the Collett farm, then proceeded chronologically to current times. He reported on a skirmish with the Indians who had entered the area to hunt in violation of an earlier treaty. Both whites and Indians were killed in the fight which occurred near the Chariton River east of what is now Connelsville. Schneider told of the building of the triangular

shaped Ft. Clark in 1832, also at the Collett site, and of Ft. Matson, built in the east side of the Adair County. Both forts were a result of the Black Hawk War and were soon found to be unneeded and abandoned. He told of the founding and naming of Kirksville and the building of the first courthouse near the site of the current Bank Midwest. The second courthouse was on the site occupied by the current courthouse which was a park at the time. It accidentally burned in 1865. Schneider spoke of the effort to get a bond passed for several decades to build the third and current courthouse. A bond finally passed in 1897 and construction began in 1898. It was among the first in the state to be equipped with modern plumbing and electricity. He described the terribly destructive tornado of April 1899 that swept through the eastern side of Kirksville. The founding of osteopathy by Dr. Andrew Taylor Still was another topic described. Schneider's talk was very interesting and informative, but by necessity had to be brief. He did not cover the Battle of Kirksville, since he had previously spoke on that event at an earlier meeting. Also pictured is SAR member Pat Richardson, chancellor of the Chapter.


November 21: "The Life and Times of Tom Horn (1860-1903), a Native of Scotland County" by Compatriot Boyd Bissell



Boyd Bissell (on right in photo), one of our own, gave the program on Tom Horn, a native of Scotland Co., Missouri (pictured below). Horn was born to a farmer there in 1860. He left home at age 14, probably because of an abusive father as well to seek adventure in the west. He at first got a job with a freight company out of Kansas City serving in various capacities. At age 16, he headed southwest and became involved with the Apache wars and eventually negotiated the surrender of Geronimo. He later quit the Army and became a ranch hand and a world class rodeo steer wrestler. Horn became an expert tracker and marksman and hired out his skills to the cattlemen and sheepmen wars in AZ, later became a deputy sheriff in Colorado. Due to his tracking skills he was later hired by the Pinkerton detective agency. He worked out of the Denver office and did investigations mostly in Colorado and Wyoming. After leaving that agency he became a "Range Detective" for the Wyoming Stock Growers Association.

Some say his actual job was "Killer for Hire," to eliminate known cattle rustlers and robbers. Although several were found dead and Horn was suspected, he was not convicted of any of those murders. During the Spanish American War he left that work and joined the U.S. Army and at one point delivered mules to Teddy Roosevelt who used them to storm San Juan Hill in Puerto Rico. Horn contracted malaria and when his health recovered, returned to Wyoming. While there, a 14-year-old son of a sheepherding rancher was murdered and Horn was arrested. Because of statements made while he was intoxicated, and perjured

testimony by two witnesses and planted evidence, he was convicted of that crime and hung in 1903, one day before his 43rd birthday. It has been said that he was likely guilty of several murders but not that one. A mock trial conducted in Cheyenne in 1993 found Horn not guilty due to the lack of evidence. There were two movies made on his life; the latest movie, in 1980, starred Steve McQueen.

"WREATHS ACROSS AMERICA" MISSOURI VETERANS CEMETERY JACKSONVILLE, MISSOURI

On December 12th, Mike Greenwell of Shelbina, Missouri, a member of our club, read the 2009 SAR Proclamation (for text, see pdf attached to cover email) at the Missouri Veterans Cemetery, Jacksonville, Missouri "Wreaths Across America" ceremony. This annual event is held simultaneously at National and State veterans cemeteries throughout the nation to honor the sacrifices of our veterans. During the ceremony, seven wreaths were hung, one to represent each branch of service (Army, Navy, Marines, Air Force, Coast Guard, and Merchant Marines) plus one for POW/MIAs. Missouri has six state veterans cemeteries with Jacksonville being the only one north of the Missouri River.

TODD KUHNS ON PICKLER'S FAMOUS: Todd, TSU web services manager and Kirksville's mayor pro tem, spoke about the restoration of Pickler's Famous building in Kirksville that he and his business partner, Dr. Justin Puckett, own. Among their goals is to establish a new business there and restore the exterior of the building to its appearance in the 1880's when it was owned by Samuel Pickler who operated a mercantile business there known as "Picklers Famous." Their business plans for the building include, along with

other as yet undisclosed uses, an ice cream parlor, lunch counter and bakery featuring artisan breads. Todd showed early and recent photos of the building. It has been an arduous task uncovering and restoring the original facade where upper floor windows had been hidden for many years. It has been even worse repairing and restoring the interior and roof supports. He and his partner have also navigated through the time consuming process of seeking historic status for the building. Once the old facade was uncovered, they were able to get a historic district designation for the north side of the square. Todd also provided some history of the building and also Samuel Pickler. He was born in Indiana on November 6, 1846; his family later settled in Davis Co., Iowa, before moving to Kirksville in 1866, where his father operated a dry goods store. Samuel took some advanced courses at the North Missouri Normal School and Commercial College (now Truman State University) during its first year of operation and the following year joined the faculty as an assistant. He became a regular instructor (teaching bookkeeping, mathematics, elocution, logic and penmenship) when it became a state school in 1870. Among his business undertakings was operating the Journal Printing Company for eight years (1873-1881). In 1879, Journal Printing was the first area newspaper to install a steam engine driven printing press. He operated a successful mercantile business at Pickler's Famous from the 1880's through the 1890's. In 1899, the business was sold to Murphy-Mills & Garges. In 1911, George Lehr bought the building and ran a furniture store there. The building housed Mart Super Drug in the 1960's; in the 1990's Radio Shack occupied the space and Lawson Hill later took over the space until 2006. CRASH OF FLIGHT #11

Duane Crawford of Unionville (right in right photo) spoke about the May 22, 1962 crash at Unionville of Continental Airlines Flight #11, a Boeing 707 aircraft with 45 persons on board (37 passengers and 8 crew members). The flight began in Chicago and was scheduled to stop at Kansas City before proceeding on to Los Angeles. The crash, from which there were no survivors, resulted from an explosive carried by a



passenger in his briefcase which he ignited in the tail section of the airplane. The fuselage from the crash landed in farmland about six miles northwest of Unionville. From pieces caught in the jet stream, wreckage was scattered over a wide area, including as far away as Iowa City, Iowa. This was the first bombing of a civilian commercial passenger aircraft in our country's history. The FBI determined that the explosive had no timing device which shows that the bomber was on the plane. The FBI investigation revealed that Kansas City, Kansas passenger Thomas G. Doty purchased six sticks of dynamite prior to the flight and also bought a large travel insurance policy before boarding. Doty had recently been arrested for armed robbery and a preliminary hearing on this charge was scheduled for May 25. The Putnam County Historical Society will place a memorial on the square in Unionville, which will be dedicated on the 48th anniversary of the tragedy, May 22, 2010. Numerous family members of the deceased are expected to attend the dedication. The speaker is pictured with SAR Compatriot Carold Bland who introduced him.

Connie spoke about her experiences during the five years she and her husband, Ronnie, served as missionaries on an Indian Reservation for Jicarilla Apache Indians in northern New Mexico. The reservation, with a population of between 2,000-3000 individuals, encompasses an area of about 20 by 70 miles. She spoke about the customs and superstitions of the people. She also spoke about the drug and alcoholism problem on



the reservation and the high murder and suicide rates. Part of the problem may be the steady income received from oil revenues which removes some of the incentive to be productive citizens. ROGER MOORE MO STATE PARK RANGER

Missouri State Park Ranger Roger Moore (right) spoke today and presented a slide show on Missouri State Parks and State Park Rangers in particular. The mission of the state park rangers is to provide professional law enforcement service and protection to all park visitors as well

as protection of state park property and its cultural and natural resources. Created in 1967, the Missouri State Park Rangers began with ten commissioned officers (including four seasonal rangers) for the 1968 camping season. In the beginning, rangers had to provide their own weapons and were required to keep them locked in their vehicles. Today, rangers are issued a full complement of law enforcement equipment. Rangers are issued the .40 caliber Glock 22 pistol and the Remington 870 shotgun as their service weapons. In addition, the federal government will donate surplus automatic weapons that will be carried in the ranger's car when sufficient funds are secured for needed accessories.

He has had extensive training on the subject and is certified by both the International Graphoanalysts Society and World Association of Document Examiners. Carold said handwriting analysis dates back to 4500 B.C., is reflected in Roman history in 99 A.D., and the first handwriting analysis publication dates to 1622. Studies of people who have a certain character trait, such as

emotional instability or irritability, have been shown to share a particular writing characteristic. Examples include the slant of letters or how the letter "t" is crossed. CHARLES HARRIS, WWII NAVAL FIGHTER PILOT

Charles (on right), an 88-year-old Memphis resident, was a member of the "Fighting Five," serving on the aircraft carrier U.S.S. Franklin in Japan during WWII, principally flying a FG-1D Corsair fighter plane. He received an air medal for shooting down two Japanese aircraft. He also served as a photographing pilot. The Franklin was bombed by Japan on March 19, 1945 and 894 people were lost. After the war, the aircraft carrier was mothballed for a time then scrapped.



Charles graduated from high school in 1938 and immediately joined the Navy after graduating from college in 1942. He served for 3 1/2 years before returning to his hometown of Memphis. He provided us some history of Memphis dating back as early as the 1890s. Charles ran a Chevrolet dealership there which at one time was the oldest dealership in Missouri and the 14th oldest Chevrolet dealership in the United States. DEBI BOUGHTON ON FOREST-LLEWELLYN CEMETERY

Tourism Director Debi Boughton spoke to us about the Kirksville owned and managed Forest-Llewellyn Cemetery. This is among the oldest pioneer cemeteries in Adair County that is still being used. The first burial there was about 1845 on a steep sided hill just west of the newly established town of Kirksville since that area was not suitable for town buildings or raising crops.

Most of the early leaders and notables of Adair County from the 19th century who died locally were buried there. Jesse Kirk, the city's namesake, is among them as is Andrew T. Still, founder of Osteopathy. Also interred in a mass grave there were 26 confederate soldiers killed during the Battle of Kirksville on August 6, 1862. Debi also spoke on the well received and attended annual Cemetery Theatre conducted each fourth of July weekend to raise money for the fireworks celebration which is not funded by the city or county. Interesting and/or notable citizens buried there are portrayed by actors, in period clothing, mostly from the non-profit Curtain Call Theatre Company.

HISTORY OF KNOX COUNTY by BRENT KARHOFF

Newark, the first town in Knox county, was established in 1835. However, the county, established in 1845 from Scotland County, named Edina as its county seat. Edina was first laid out in 1839, with the post office established there in 1842, but was not incorporated until 1851. As with most counties with small populations, there were many small towns and rural schools established in the 19th century before all-weather roads



(Mike Richardson & Brent Karhoff)

made travel easy. When the east - west railroad was built in 1872 (initially named the Q.M.&P.), some towns were established along its track and others, not so fortunate, shriveled or died. In 1887 the Santa Fe railroad between Chicago and Kansas City was built through the northwest corner of the county. In the early 1980s the Q.M.&P. (by then named the Q.O.&K.C., nicknamed the "O.K.") was defunct and the Santa Fe became the only railroad remaining in the county. It still passes through Baring but no longer makes stops in either Knox or Adair counties. During the Civil War, the northern part of Knox county, settled by many German and Irish immigrants, leaned more toward the Union side and those settlers in the south part of the county that came mostly from Kentucky and Tennessee leaned toward the Confederate side. The rural schools were more and more consolidated and by 1963, the high schools were centralized and a new high school was built east of Edina. The county had a population of about 12,400 in 1910 and is currently at about 4,000. Many of its residents travel to Kirksville or Quincy for employment and shopping for items not available locally.

local air service which receives a federal subsidy under the Essential Air Service Act. The minimum of 593 passengers per month has been exceeded each month since the current airline, Cape Air, began service. Airfare is just \$49 and tickets can be purchased on line, at the downtown ticket office or by calling 1-866-Cape-Air. MIKE ON FLYING TIGER MEMORIAL IN CHINA:

Mike Richardson gave our program today concerning his visit to a Flying Tiger memorial in the interior of mainland China while visiting his wife's family. A private military contractor formed the Flying Tigers in 1941 in cooperation with the U.S. Government. It was formed in response to the

Japanese invasion of China and was made up mostly of pilots and support personnel from the U.S. Military. They flew fighter planes with large shark teeth painted on the nose of their planes making them look very fearsome. They were paid roughly three times what they were making in the U.S. forces and were paid a bonus by the Chinese for each Japanese airplane destroyed. During their service in China they destroyed 300 Japanese aircraft while losing only 14 of their own in combat. In July 1942, after the U.S. had declared war on Japan, the group was absorbed into the U.S. 14th Air Force and went on to achieve similar results while maintaining the nose art on their planes.



CAROL WILSON RECEIVES MARTHA WASHINGTON MEDAL AND CERTIFICATE OF RECOGNITION

At today's meeting, Chapter President Brenton presented Carol Wilson, a member of the Daughters of the American Revolution (DAR), a Martha Washington medal and certificate of recognition. Male blood relatives of DAR members may use that relationship in part to base their qualification for SAR membership. The SAR provides a medal for any DAR member who has successfully recommended three such men for membership.

MIKE CONTINUES PROGRAM ON "FLYING TIGERS"

At our January meeting, our fellow chapter member, Mike Richardson, spoke about visiting the "Flying Tigers" Memorial in Zhijiang, Hunan Province, China including his problems getting there and about the "Flying Tigers" in general. He told us today that, although there are 11 museums in the world that include information on the Flying Tigers (including two in the U.S. and two others in China), the Memorial in Zhijiang is the only museum in the world dedicated exclusively to that group. He spoke more today about the history of the 1st American Volunteer Group (AVG) nicknamed the "Flying Tigers." The AVG was principally the creation of Retired U.S. Army Air Corps Officer Claire L. Chennault who had worked in China beginning in August, 1937. This private group was formed with the blessing of president Roosevelt, but not publicly and without federal funding. The group was consisted mostly of



pilots and support personnel and was in combat for the first time on December 20, 1941. Its members were a "special breed" of young, adventurous men who were highly paid for their services including a \$500 bounty for each Japanese aircraft destroyed. Mike spoke about their operations and the politics surrounding the group which was eventually absorbed in the U.S. 14th Air Force in July 1942. He circulated a list of the men who served in the Flying Tigers.

SPEAKER: WWII SNIPER TED GUNDY. At our November 2011 meeting, Compatriot Boyd Bissell showed a video of a TV program on Memphis, MO resident Ted Gundy which aired on the Outdoor Channel. Gundy was honored with a weeklong visit to Fort Benning, GA in 2009 as a guest of the U.S. Army and Army Markmanship Unit. He was able to make his "dream shots" in which he successfully hit a small target three times at 1,000 yards using a modern weapon! Although Gundy was not able to attend our November meeting (he was hunting that day), he promised to give us a program in person - which he did today! He spoke about enlisting in June of 1944 and shipping overseas in December of that year. He served in the Battle of the Bulge in Belgium. He was wounded in a Cologne plains battle where his entire squad of 12

soldiers was wiped out except for him and his buddy Charles Jones who Gundy credits with saving his life. Gundy tried to control the arterial bleeding of his leg with a belt as he had been trained but the belt buckle fell off! Jones risked his life to apply a tourniquet to Gundy's leg. He was flown to England where his foot turned black (dry gangrene). He eventually had his leg amputated just below the knee. He was able to reconnect with Charles Jones of Bloomfield, Missouri who died about three years ago. After leaving the service on April 6, 1946, he had trouble finding a job but ran for Scotland County Collector, where he served 5/4-yr. terms, followed by 30 years as a rural mail carrier.

OCTOBER AND NOVEMBER PROGRAMS: At the October 20 meeting, Judge Karl DeMarce of the Scotland County Associate Circuit Court, gave a presentation on the 2007 discovery of the missing St. Louis Probate Record Book A which gave a glimpse into the lives of both notable and ordinary people in the early history of Missouri and the rapid changes both socially and economically. The November 17th speaker was Missouri 2nd District Circuit Judge Russell Steele who gave a power point presentation on the history of the Federal Judiciary and some of the first Supreme Court cases that established the courts power as a viable branch of our federal government. He also gave a history of the Missouri Non-Partisan Court Plan and its success and how it has been copied by other states.



TODAY'S PROGRAM - SALVATION ARMY: Lt. Brian Bump of the local Salvation Army spoke about the annual Christmas kettle campaign and its history. In 1891, Salvation Army Captain Joseph McFee, resolving to provide a free Christmas dinner to the poor in San Francisco, remembered a sight he saw in Liverpool, England. From his days as a sailor McFee remembered a large pot displayed on a landing in which passersby threw in money for the poor. Taking this idea, McFee asked for permission from San Francisco authorities to place a crab pot and tripod at the Oakland ferry landing. The kettle - and McFee's call of "Keep the Pot Boiling" - drew in passengers and donations. The idea spread and is in use by many Salvation Army charities worldwide. Lt. Bump said his goal for the Kirksville kettle campaign this year is \$41,000 (part of \$90,000 for annual fundraising drive). The funds collected will not only provide Christmas food

baskets and toys for children but also gifts to nursing home residents. In addition, the Salvation Army provides help with utility payments and transportation assistance. Lt. Jeff Doss (right) spoke about the duties of the office. After being elected, the position requires twenty hours of death investigation training at the state level. In absence of the coroner, the sheriff performs the duties. A county coroner has the authority to remove a sheriff from office. SPEAKER - COMPATRIOT LARRY POTTER ON HIS STUDEBAKER

ANCESTORS: Larry provided this summary of his very interesting talk: When I was a young boy my grandmother, Vivian Mahurin Cathey passed down an oral history of her grandmother, Julia Ann Studabaker Matter. Julia Studebaker's father, Henry Studabaker's (Studebaker) had family in Pennsylvania molested by the Indians where the mother and father were killed and the children were taken back to the Indian village. Once there the children were taken to an ice cold creek and dunked into the water. Whoever survived was adopted into the tribe. She was also related to the Studebaker wagon and automakers. In 2011 I began to research this

story which led me to the Studebaker National Family Association and Volume 2 of "The Studebaker Family in America." The Studebaker book had the complete story of Henry's Grandfather Heinrich who migrated to America in 1736 with cousins Peter and Clement. The descendants of Clement started the wagon and Automobile Company in Fort Wayne, Indiana.



On 3 March of 1756 in Cumberland County, Pa. Heinrich was killed and his wife and children, Joseph, Phillip and Elizabeth were taken captive by Chief Shingas of the Shawnee and Captain Jacobs of the Delaware raiding party. The wife with child, only known by her maiden name Kellough, was killed because she could not keep up with the over 200-mile journey through the mountainous landscape to the final destination, the Indian village of Kittanning. Henry's Father Phillip was released six years later and Joseph and Elizabeth three years after that. Elizabeth returned to the Shawnee. Phillip and Joseph were in Capt. Leech's Westmoreland County Pennsylvania Militia during the Revolutionary War. Joseph died in Westmoreland at an old age. Phillip died in Montgomery County Ohio, also at an old age. In 1813, a band of Shawnee traveled over 300 miles to Joseph's farm to give him the bad news of Elizabeth's death after falling from a horse. (L. Potter is Chapter Registrar/Genealogist.)

BOYD BISSELL ON ROBERT BISSELL'S KOREAN WAR EXPERIENCES: Boyd said his 80-year-old brother Robert, a fellow chapter member, served in the Korean Conflict as a guard trained to protect several B-17 Superfortress heavy bomber aircraft on the ground in country. After an attack, the bombers were moved to England and Robert served there, living with a family rather than on base. Boyd said Robert and his family very much appreciated the Korean medal and bar, along with a certificate, sent to him by President Brenton Karhoff. Boyd particularly thanked Larry Potter for his

efforts in establishing Robert's qualifications for the medal. Boyd is pictured with Vice President Gary Lloyd who conducted the meeting in President Karhoff's absence.

NOTABLE BISSELL ANCESTORS: Boyd said that sawdust was a big problem for **Melville R. Bissell** and his wife Anna in the small crockery shop they owned in Michigan until, in 1876, he invented a unique carpet sweeper and patented it. (Boyd displays the sweeper in right photo.) Customers and friends wanted to own one, so a new business was born. When Melville died in 1889, Anna stepped in to run the business, the first female CEO in America! The business has expanded and prospered to this day. Boyd also spoke about **William Henry Bissell** (1811-1860) who helped found the Republican party in Illinois and was the first Republican to sit as governor of the state.

SPEAKER: DEWAYNE WELLBORN ON ST. MARY'S CHURCH IN ADAIR, MO



(Thanks to Compatriot Larry Potter for the photo and the following report on Mr. Wellborn's talk.) Dewayne Wellborn of the Friends of St. Mary's, a nondenominational organization dedicated to the preservation of the historic St. Mary's Catholic Church, spoke about this church located in the village of Adair, Missouri. Listed in the National Historic Register, St. Mary's was built in 1904 at a cost of \$10,000. The Church was designed in a unique Roman style

with two towers along the front. One tower represents the Ionic while the other represents the Stoic architectural style. Another unique architectural feature is the three high windows representing the Holy Trinity. St. Mary's was the center of community for Adair's mostly Irish citizens. Adair was settled by a large number of Irish from Limerick, Ireland who sought escape form the great potato famine. Adair was once a bustling community with merchants and craftsman ranging from makers of hats, shoes, and brooms. The village's population went from over a hundred in the early 1900s, to just a few now. The last Mass was held in December of 1972. Mr. Wellborn encourages anyone wishing to take a tour of St. Mary's to contact him. He will either make arrangements to meet you there. Or just stop by his house and he will lend you a key for self-guided tours. Mr. Wellborn is pictured above with Chapter President Brent who introduced him.

SPEAKER: DAVID O. ERWIN, ADAIR COUNTY COLLECTOR OF REVENUE

David discussed the taxes that are collected by his office and how the proceeds are dispersed to the various entities in the county that depend on taxes for their operations. He said individual property taxes are calculated on the basis of each \$100 of assessed value. The appraised value of personal property or real estate is determined by the State or County Assessor. The assessed value is a percentage of the appraised value of the item; you do not pay taxes on the full value. Some examples: licensed vehicles - 33

1/3% of State appraised value; residential real estate - 19% of assessor appraised value; agricultural real estate - 12% of State assigned values per class (8 classes, with the best farmland being class 8 and land unsuitable for farming being class 1); and commercial real estate - 32% of assessor appraised value. He used as a specific example that the tax on a residential property located within the Kirksville city limits with an appraised value of \$100,000 would be \$1,074.77 (\$100,000 x 19%/100 =190 x \$5.6567 = \$1074.77). He had several handouts including a tax and assessed value comparison report covering yearly figures from 2006 to 2012. Total assessed values increased from \$228,946,910 to \$260,953,905 during that period. Beneficiaries of tax revenues include schools, roads, Twin Pines (or LaPlata) Nursing Home, the library, health department, ambulance, and SB-40 (handicapped services). David said all collectors in the state are required to take training classes each year for 20 hours to keep up to date on all changes. The session is held each Spring in Jefferson City. David has been involved in training newer collectors for the past several years. The county collector is an elected position. JOHN MURPHY ON MO DEPT. OF CONSERVATION PRIVATE LAND SERVICES

John Murphy (left), a native of the Eastern Shore of Maryland, serves as a private land conservationist at the DOC Northeast Regional Office, 3500 S. Baltimore. Kirksville. He was one of 37 biologists hired in the state of Missouri when this program first began in 2000. The program's mission is help landowners meet their management objectives in ways that enhance fish, forest, and wildlife conservation. They work proactively with other government agencies and private sector groups to enhance conservation activities on private land. Their services are particularly important since over 93% of Missouri's land is privately owned and,



in northeast Missouri, the figure is 98%. They aim to provide timely and quality service to all Missouri landowners requesting their services. These services include grassland, savanna, and woodland management as well as wildlife damage control and habitat restoration. There is also some activity in wetland restoration and management. Their activities follow certain seasons, with pond work dominating their work from June to August. John said every Missouri county has someone assigned to provide these services and encouraged us to contact their local agent. CAPTAIN STEVEN FINES, ASSISTANT PROFESSOR OF MILITARY SCIENCE, TRUMAN ROTC BULLDOG BATTALION ON SEXUAL ASSAULT AWARENESS TRAINING:

Archeological digs have discovered an ancient city with walls fifteen feet thick and thirty to forty feet high before they were destroyed by past conquerors. Dr. Appold elaborated on archeologist approaches to uncovering material at ancient sites in order to advance the knowledge of history.

SPEAKER - KIRKSVILLE FIRE CHIEF

Kirksville Fire Chief Tom Collins (right) spoke about the Fire Department generally and answered our many questions. After serving 27 years in Independence, he accepted the fire chief position here in February. He said his department has 18 full-time firefighters (including himself) working three shifts. The firefighters work 24 hours on, followed by 48 hours off. He said he is currently looking for paid on-call people. Civilians are being trained under a CER (Community Emergency Response) program. He said a MACC course is being considered for individuals 18 and older which would help not only recruitment of new city firefighters but also provide more training for rural fire departments. It would meet 2-3 nights per week and a couple of Saturdays. Asked whether volunteers would be welcomed in specific incidents, Chief Collins said yes. We should look for a firefighter with a white helmet or green light who would be able to tell us how we could help. We talked about the ladder fire truck



purchased in recent years for \$600,000 (would now cost over \$ 1 million). Brent said, without this truck, Edina's church would have been lost to fire. Chief Collins said outside counties are not billed for their services but they reciprocate when needs arise. ROTARIAN MARCY PALERMO ON GROUP STUDY **EXCHANGE TO FRANCE**: Marcy, a longtime friend of Larry and Terrie Potter, spoke about her experiences as a member of a Rotary Group Study Exchange (GSE) to the French Riviera from October 2010 to March 2011. Rotary's GSE program is a unique cultural and vocational exchange opportunity for businesspeople and professionals between the ages of 25 and 40 who are in the early stages of their careers. The teams from different countries exchange visits for four to six weeks (or longer) to experience the host country's culture and institutions, observe how their vocations are practiced abroad, develop personal and professional relationships, and exchange ideas. Marcy said the French people, Rotarians and Non-Rotarians alike, were very kind to her. She traveled extensively in France and Monaco, visiting various facilities including a call center located in a cave under a casino. The call center was of particular interest to Marcy since she has worked in that field. Marcy said the people of France greatly appreciate what the United States did for their country during World War II. The entire GSE experience was very rewarding for Marcy. She has been a member of the Rotary Club of Kirksville for several years now and has been giving back to the community. The GSE team from France visited several locations in Kirksville, including the Thousand Hills State Park, Round Barn, a Blues Festival, and, of course, our famous "Pancake City." They also visited Kansas City before returning to France.

PROGRAM: Our guest speaker was Troy Mihalevich, Director of EMS Education at the Adair County Ambulance District. Troy is also a Board Member of NEMO Heart Health, a nonprofit whose mission includes to create awareness, education and maintaining access to AED's or Automated External Defibrillators in Kirksville and the surrounding areas. Troy brought with him a CPR mannequin and a AED to demonstrate the ease of use of this life saving device. In his presentation he stressed the need for the community to familiarize itself with and use the AED's in

medical emergencies. "There were events in the community where someone was suffering a sudden cardiac arrest and the AED available was not used". At one business, an employee was suffering sudden cardiac arrest and with the quick thinking of fellow employees within minutes he was administered CPR in conjunction with the AED. This was a life saving event until the ambulance arrived. The ideal time is three minutes to start defibrillation and CPR after cardiac arrest, then the patient has a 70% chance of survival. For each minute the patient waits the chance of survival is reduced by 10%. NEMO heart Health has installed over 100 AED's in Kirksville and the surrounding area. TRUMAN HISTORY PROFESSOR MARK HANLEY ON THE LAST 10 YEARS OF ABRAHAM LINCOLN'S LIFE

TSU History Professor Mark Hanley (right) spoke about Lincoln's evolution in thinking about equal rights and the issue of slavery between 1855-65. In the 1858 Lincoln-Douglas debate, Douglas pressed Lincoln hard on the issue of equality for blacks which Lincoln did not support at that time. He said he would not touch slavery where it existed, but wanted to prevent its spread to new states as they were established. He believed if it were contained, slavery would eventually die out in the South. When the Civil War broke out in 1861, Lincoln said it was not a war to end slavery, but was to save the Nation. After the victories at Gettysburg and Vicksburg, however, Lincoln began to develop new views towards freeing blacks and issued a proclamation to free blacks who lived in those states fighting the union. He later worked hard in getting a constitutional amendment passed for their freedom. John Wilkes Booth was an attendee at an April 11, 1865 session on voting rights for blacks. Booth assassinated the president three days later. Hanley said Abraham Lincoln was a remarkable president, willing to change and evolve as a leader. He wonders what more Lincoln would have accomplished if he had been able to finish his term as president. The speaker is pictured with Chapter President Larry Potter who introduced him.

CECOLIA "SCOTTY" MIHALEVICH ON HISTORIC BEAR CREEK BAPTIST CHURCH




Cecolia "Scotty" Mihalevich spoke about the Bear Creek Baptist Church and cemetery. The church, established in 1838/9 and identified as the oldest Christian church in Adair County, was

placed on the National Historic Register April 25, 1984. Construction the of church building began in 1860 and was completed by 1865. The last service there held was February 7, 1914; however, burials have continued well beyond that date. Scotty said she



believes there are 450-500 graves there, many of which are unmarked. The church has fallen into significant disrepair. The cemetery, however, has been well maintained. Scotty has had responsibility for the cemetery since 1976; she serves as

MARY MC INTOSH, STATE ARCHIVIST: For the last 23 years, Mary has worked as a local records field archivist, a position she loves which requires extensive travel in northeast Missouri visiting courthouses and city halls. It involves organizing local records in preparation for microfilming and/or computer inventory. Missouri's program is one of only three in the United States. There are ten archivists in the State of Missouri and two individuals working in administration in Jefferson City. Mary's travel demands have been relieved somewhat since Truman's judicial archive internship program began in 2012. (She has an office in the former Grim

Smith Hospital building.) Another archivist has taken over some of her workload because of the supervision demands of the internship program. Mary shared interesting stories about her work including sometimes encountering bats, mice and once a snake in records storage. She spoke about the 1999 Mississippi County courthouse fire;

records were not entirely destroyed but were covered in thick mold requiring the efforts of a large team of archivists. Mary brought numerous records for her talk which we were able to peruse after her presentation. Some records she has seen dealt with the slave and fur trades, records on the lawsuit brought against

MAYOR JEFF DODSON, CITY OF NOVINGER

After our business meeting, Chapter President Larry Potter introduced our guest speaker, Jeff Dodson (right). Dodson followed in the footsteps of his grandmother Juanita Summers who served as Novinger mayor for 13 years beginning in the 1970's and became Novinger's mayor himself in April, 2009. This was just before the significant tornado which struck Novinger (as well as Kirksville) on May 9, 2009. He credits the Novinger Volunteer Fire Department and other volunteers for the extraordinary recovery efforts. These volunteers were able to open all but one of Novinger's 27 roads and streets impacted by the tornado in record time. A fleet of trucks could be seen up and down Route 6 restoring all electric power in just five days. There were 500 outside volunteers from Iowa, South Missouri and Illinois helping with the recovery efforts. The community pulled together to provide meals for everyone! Unfortunately, this was not the end of hardships to hit Novinger. These include floods and a major fire on September 11, 2011 which destroyed several downtown buildings. Under Mayor Dodson's leadership,

the city has bounced back. In 2012, Novinger placed first in the Missouri Community Betterment competition in youth and community areas within its classification by size. Honors were repeated in 2013. Novinger has a Facebook page and a website http://www.cityofnovinger.com. In the last four years, seven new small businesses have been formed. Dodson was able to arrange for Tool Box Ministries out of Nashville, TN to complete \$230,000 worth of home and city improvement projects here. In just five weeks, he was able to raise \$16,000 for a full basketball court across the street from the school which was constructed by 60 volunteers. Extensive sewer system improvements have been made to meet EPA regulations and other water projects undertaken. A \$162,000 demolition grant has been obtained to remove eyesores and make available properties for development. A new duplex is planned and 25 applicants have expressed interest in renting (a three-bedroom apartment to rent for \$550/month). Increasing Novinger's population would help the school system greatly. Dodson is happy to report that, due to good management, Novinger is debt free and moving forward.

SPEAKER: GUARDIAN AD LITEM PHIL MC INTOSH

Phil spoke about his responsibilities as Guardian Ad Litem, a position he will have held for 19 years this July, which involves looking out for the best interest of children. His services are required by the court in adoption and guardianship cases. He interviews children who are victims of child abuse and neglect or are in homes where domestic violence is an issue. VSS statistics show that 89% of children in households where there is physical abuse between parents become abusers themselves; the figure was just 80% a few years ago. Drugs, alcohol, and prescription drug abuse are involved in many cases. He said unstable behavior is exhibited in 9 out of 10 children of alcoholics. Emotional abuse and sexual abuse are also problems. Toward the end of his talk, Phil had each of us guess the number of Skittles in a plastic container and write our answers on stickup notes. Guest Reta Davison was very close to guessing that there were 13,156 Skittles - a number that represents the children in foster care in Missouri. (Nationwide the figure is 1/2 a million.) Phil said there is a shortage of foster parents. He asked, if we know individuals with the heart and stamina for the job, that we encourage them to become foster parents. CHAPTER PRESIDENT LARRY POTTER ON THE PENNSYLVANIA LINE

Compatriot Potter spoke about his ancestor Peter Wyrick who enlisted 9 August 1776 at Pittsburgh, PA and served in the 8th Pennsylvania line for more than three years under Colonel McCoy and Col. Daniel Brodhead and was discharged by Colonel Byers. (Larry spoke about Peter's 1881 will which we found interesting. He left 25 acres each to four sons, a bed and a cow to each of four daughters when they married, and five shillings each to two more sons and another daughter.)

In July 1776 Mifflin's Division, 2nd Pennsylvania Brigade, 8th Pennsylvania Regiment, assembled at Kittanning, PA for the 300-mile march to Quibbletown/New Market, New Jersey beginning in January, 1777. (Larry showed us the trek on a large map.) From Quibbletown, they fought their first battle 13 April 1777 at Bound Brook, NJ. The troops were ill prepared - no blankets, kettles, tents, arms. A number of men died in battle and some deserted. They fought in the Battle of Brandywine 11 Sep 1777, where they were outnumbered and withdrew. The Battle of Paoli followed 21-22 Sep 1777 and the Battle of Germantown 4 Oct 1777. Of 11,000 men, 30 officers and 121 troops were killed, 521 were wounded and 400 were taken prisoners at Germantown. The British had 71 killed and 448 wounded. This regiment served in part of the Battle of Saratoga and was present but not engaged in the Battle of White Marsh. They wintered at Valley Forge, PA in 1777-78.

Compatriot Potter read several interesting orderly reports from Draper manuscripts, many of which dealt with firing of guns (for recreation) and supplying spirits, important to the troops. Larry Potter (left) is pictured with his first cousin Donald Potter who got Larry interested in his family's history and its military history.

RON BROWN ON MEMPHIS, MO BIPLANE

Compatriot Boyd Bissell (right) introduced today's speaker, Ron Brown, who provided a history of The Pheasant Aircraft Co. of Memphis, MO and its biplane, the Pheasant H-10.

Pheasant H-10s were built between June of 1927 until May of 1929. The H-10 Pheasant was a tandem-seat conventional landing gear-equipped biplane with fabric covering built by Pheasant Aircraft Co. to compete in the crowded market of barnstorming biplanes.

The founder and first president, Lee R. Briggs, and a student pilot were killed in a tragic accident December 5, 1927. Pheasant test pilot Steve Wittman entered The H-10 in the September 8, 1928 Air Derby from New York to Los Angeles. Delayed due to radiator trouble in the desert, Wittman finished 12th out of 38 entries. Wittman raced again in the 1928 Air Derby from Los Angeles to Cincinnati and finished in 4th place. He also entered the H-10

in the 1929 National Air Races in Cleveland, OH.

The Scotland County Historical Society acquired one of the last three surviving Pheasant H-10 biplanes. Previously located in Long Island, NY, residents of the Memphis area donated over \$75,000 in 2012 to purchase and transport the H-10 back to the city of its manufacture. The plane is on display in the Wiggins Tractor Museum in Memphis, MO. According to Ron Brown, there is still one local individual alive who remembers actually seeing one of the planes in flight, Martin Guinn of Rutledge, MO.



ADAIR COUNTY REVOLUTIONARY WAR VETERAN JAMES FLETCHER, JR.

Linda Hudnall, Regent, Ann Haynes Chapter, Daughters of the American Revolution, spoke to us today about undertaking a joint SAR/DAR project to preserve the gravesite of James Fletcher, Jr.

James is buried in Adair County on the old Amsbaugh Farm where he lived, now owned by the Weber family. He was born in 1758 and served as a private in the Virginia Militia, Continental Army. In about 1830, at age 72, he moved to Missouri with his son and family. He died September 27, 1845 at the age of 87. Linda thanked Gary Lloyd for his research into this soldier's history (see https://sites.google.com/site/glloydsite/Home/adhistarticles). She was able to share this information with his 5 times great granddaughter, Denise Knowles, who was interested in visiting Fletcher's grave. On Memorial Day weekend last year, Gary and Claire Lloyd led a group of DAR members and friends on a trek out to this remote gravesite. (Unfortunately, a family illness prevented Ms. Knowles from joining them.) For your information, Linda's remarks at the Fletcher grave are attached to cover email.

DR. LARRY WIGGINS ON THE OLD SCOTLAND COUNTY COURTHOUSE AND MORE

Compatriot Boyd Bissell introduced today's guest speaker, Larry Wiggins, DVM, who spoke about the old Scotland County log courthouse, built in 1834, which had been at Sand Hill, Missouri, northwest of Rutledge under an old barn roof that had collapsed on it. On behalf of his Memphis museum group, Dr. Wiggins paid \$1500 for it with the purpose of moving it to Memphis. That has since been accomplished and reconstructed all by volunteers log by log within a new museum building there in order to preserve and display the 180-year-old courthouse. The oak logs weighed 900 pounds each!

Dr. Wiggins also spoke about plans to restore and similarly display (in Memphis) the Arbela depot and a filling station. (In addition to his museum and historical society work, Dr. Wiggins has an active veterinary practice and has 300 head of cattle.)

He spoke about the generosity of local residents as evidenced about them raising \$75,000 in the past to pay for a Pheasant bi-plane, which had been built in 1929 in Memphis. It is one of only three remaining Pheasant bi-planes and was brought to Memphis from Long Island, New York. The plane is on display in Memphis, along with other exhibition items which can be viewed by contacting someone from a list outside the museum. Dr. Wiggins said many large groups have viewed the museum exhibits.

Gary suggested maybe, if approved by the group, the chapter could visit Memphis in the spring, eating at a local restaurant, with a view toward seeing the museums. Dr. Wiggins said they have a meeting room we could use if we wanted.

"VETS WITH A MISSION"

Ron Martin (left) served as a data processing technician on the U.S.S. Niagara, a refrigerated supply ship replenishing aircraft carriers during the Vietnam War. He said the country is still recovering from the ravages of war and he wanted to help the South Vietnamese people. He became part of a veterans group, "Vets With A Mission," a not-for-profit humanitarian organization and ministry. It began its humanitarian mission to Vietnam in January 1989 and it continues to be active today. Mr. Martin returned from a 2 1/2-week mission there on April 1, his second trip since 2016. His team provided support at three medical clinics outside Da Nang and he showed us a slideshow of the mission. He said

Vietnam is 50% Buddhist and 10% Christian. Although private ownership is allowed in this communist



country, few can afford it. Martin said there are two classes of people in Vietnam and poverty is widespread. He is pictured with Chapter President

Larry Potter who introduced him. Also pictured is Vietnamese currency, a 2000 Dong note, worth about eight cents in U.S. money.

THE FLETCHER GRAVESITE: Chapter President Larry Potter and his wife, Terrie, visited the gravesite on May 21. Larry believes fencing the gravesite is unnecessary and could draw attention to the site and result in vandalism. This is on everyone's mind after the extensive recent vandalism of tombstones at the Forest Lewellyn Cemetery. There are no cattle on the Weber farm and haven't been for years; however, Gary pointed out that fencing might not keep cows out anyway. Ninevah Cemetery was fenced several years ago allowing the grass to grow up high and lush. When the surrounding pasture was short and sparse, cattle knocked the fence down to get to the grass and broke most of the tombstones. Larry suggested we just weed eat there and possibly consider cleaning the stone. We would need to research cleaning techniques that wouldn't degrade the stone and report back at our next meeting (in September). Members present agreed we shouldn't fence at this time. Larry will talk with Linda Hudnall of DAR who proposed partnering with us on the gravesite improvements.

JAMIE LIVINGSTON, DIRECTOR ADAIR COUNTY PUBLIC LIBRARY

Jamie Livingston has served as library director since February 2016, replacing Glenda Hunt who retired. She previously served as library director in Centerville, Iowa and also in Unionville, MO. She holds a Master's degree in Library Science from the University of Iowa. Jamie is an Iowa native who married a Missourian. They have a 20-year old daughter who attends Truman State University.

Jamie, one of only four full-time employees, began her talk by inviting us to visit www2.youseemore.com/adaircpl for information about the library. She said a lot of the library's programs are geared toward children, including a Teen Book Club and Lego and Pokemon events. Movie Night, however, last night drew 59 people of all ages for "Hocus Pocus." She said library cards need to be renewed yearly. As a cardholder, you can use the following sites at home: Heritage Quest, Learning Express, and EBSCOHost. The library has various genealogy resources including Ancestry.com. You can renew books, put a hold on books, or get books on an inter-library

loan (which takes about a week). Jamie spoke about their new microfilm equipment for which they got a grant for 75% of the cost. It can crop, enhance and print. You can use a flash drive or email items to yourself. The library subscribes to 72 magazines and four newspapers. In addition to standard books, they have free eBooks. They also have Music CDs and DVDs for adults and kids (including new releases) which you can check out for one week. Some unusual items you can check out: fishing poles with small tackle boxes and two American Girl dolls with outfits. Jamie expressed her appreciation of "Friends of the Adair County Public Library" which assists with the summer reading program and runs the monthly book sales. Friends membership is \$10/year. Jamie said the library is very short of storage space and she and the board are hoping to expand to their north side someday. However, that would require a voter approved increase in the tax levy. LARRY WIGGINS SPEAKS ABOUT LOG COURTHOUSE AND NEWLY MOVED WWI MONUMENT



YEARBOOK FOR 2017: Claire Lloyd produced the Ninth Annual Chapter Yearbook and shared it with members for review today. (She and her husband, Compatriot Gary Lloyd, maintain past yearbooks.)

OUR REVOLUTIONARY WAR ANCESTORS: On Chapter President Larry Potter's suggestion, today's program was discussion of our patriots.

Gary Lloyd said his patriot was his 7th great grandfather, Daniel Easley, Sr. (1720-1786). Daniel Easley was born and died in VA (Goochland County and Halifax County) and had civilian service in the American Revolution by provision of supplies. Gary's line runs through surnames Easley, Adams, Guffey and Lloyd.

John Sparks reported that his ancestor was Samuel Eason (1755-1813), from Washington County, Virginia, who enlisted late in

1778. He married in 1780. His widow was unable to draw a pension because she couldn't prove he served for at least six months. His wife moved to Schuyler

County, Missouri in the 1840's. She tried several times to obtain her husband's pension without success. She was last rejected in 1845 and does not show up in the 1850 census.

Larry Potter spoke about his ancestor, Pvt. Peter Wyrick on the Pennsylvania Line and also about the Battle of Long Island, August 27-29, 1776. The British had them surrounded near the East River in Brooklyn and General Washington made his escape with his army by crossing the East River very quietly by night. Once across, they proceeded north to Fort Washington and then across the Hudson River to New Jersey. He left a contingent of soldiers behind to man the fort and the soldiers were all captured by the British and put in prison ships in the harbor.

MOSSAR PRESIDENT DENNIS J. HAHN WELCOMED: Each of the seven members present introduced themselves and spoke briefly about their patriots. President Hahn from St. Charles, Missouri, a Truman graduate (Class of 1966), spoke about himself and his patriot. His patriot served both in the Revolutionary War and in the War of 1812. Pictured in photo at left: MOSSAR President Dennis J. Hahn with Chapter President Larry Potter.

President Hahn reported on the March 10 dedication that he led of the SAR Plaque Commemorating the "Iron Curtain Speech" and Honoring Compatriots Sir Winston Churchill and President Harry S. Truman. It was held at the National Churchill Museum in Fulton.

President Hahn provided some interesting information about the Missouri Society. It has 774 members including 48 life members and

32 junior members. That number does not include dual members of which there are four. There are 15 chapters (Cape Girardeau, Columbia, Harrisonville, Independence (2 chapters), Jefferson City, Joplin, Kansas City, Kirksville, Liberty, Rolla, Springfield, St. Charles, St. Louis and Warrensburg) and range in size from 10 to 115 members. He said his chapter, which will be 21 years old in May, has 80 members. It has had 20 deaths in its 21-year history. The Missouri Society of the Sons of the American Revolution began in 1896 in St. Louis. There were no chapters at that time but Kansas City wanted a meeting place and one was set up. It became inactive in 1921 and there were no chapters between 1921-1965. Chapters existed between 1966-1970 but none between 1970-1976. Since 1976, chapters have existed continuously. Twenty chapters have existed since that time but five of them died out. The newest chapter, Rolla, is 10 years old. He introduced us to Braxton C. Pollard, our namesake, and directed us to the Find A Grave webpage on him (copied on Page 2). President Hahn is seeking an editor for MOSSAR's publication which had its last edition in 2014. He also sought 2-3 pages on our chapter for an update on the MOSSAR Centennial book.

President Hahn invited us to attend the 128th Annual MOSSAR Membership Convention April 27-28, 2018 in St. Charles. In addition to activities outlined in the registration form, there will be three sessions on Friday (a DNA seminar, newsletter seminar, and a program on developing a website or Facebook page). President Hahn recommended getting our recruitment message out in newspapers or on Facebook, perhaps using a "Are you related to (names of patriots)?" approach. We also encouraged Color Guards for community exposure. 

Grandfather's Grandfather, Peter Creason's will dated back to 1827 from Boone County, Missouri. This culminated in a brief discussion of forts erected along the Missouri River's Boonslick area during the War of 1812 for which Peter Creason participated. The early settlers response to Native American aggression and attacks was to erect a series of stockades along the Missouri River that stretch from the upper Boonslick area to present Boonville, Missouri. Fort Cooper was located two miles SW of Boonslick. Fort Kincaid was SE nine miles distance and one mile from Boonville RR bridge. Fort Hempstead was one and a half miles from Fort Kincaid. After organizing a Militia Sarshall Cooper was made Captain. A Draper Manuscript containing a Roster of Captain Cooper's men included Compatriot Potter's ancestor Peter Creason and another notable figure, Lindsey Carson,



father of Kit Carson. The manuscript mentions Lindsey Carson was wounded in 1814 having his finger shot off by Indians. A bullet striking his hand just as he was beginning to shoot. By the Spring of 1814 a band of Fox and Sac attacked settlements along the Boonslick area with intensity. Governor Clark sent Col. Henry Dodge with 150 Rangers to help. Along with 50 Shawnee scouts and 90 of Captain Cooper's Militia they headed to the Piankeshaw Miami village near the town of present day Miami, Missouri. These were Indiana Indians removed by Harrison in 1811. Outnumbered, 150 Miami Indians surrendered with the promise they would not be harmed. The Boonslick Militia found a rifle belonging to Campbell Bolen who was slain earlier. The Boonslick Militia was prepared to massacre the Miami, but Dodge intervened. Daniel Morgan Boone arrived and backed Dodge. The Militia relented and was mustered out at Arrow Rock. Dodge escorted the Miami back to the Mississippi River to return to Indiana. Compatriot Potter noted his ancestor Peter Creason's name appears in a muster role in Lt. Col. Dodge's Command. Missouri Militia, War of 1812. It appears he backed Dodge as well. Captain Sarshall Cooper was later killed by an Indian who dug an opening in his cabin and shot and killed him as he was sitting in a chair. Compatriot Potter concluded this was just a peek into the history of the Boonslick area. He also noted Compatriot Charles Kerner's patriot ancestor, James Calloway (a compatriot of Daniel Boone) lived in the Boonslick area during this time. MEYER, **SENIOR** HISTORICAL MICHAEL J. ARCHEOLOGIST of the Missouri Department of Transportation (MoDOT), Historic Preservation section, is pictured with Chapter President Larry Potter (right). Mr. Meyer is a Mizzou graduate who obtained his Master's degree from Florida State University. His career in archeology has taken him from Louisiana east to Virginia and every state in between. He returned to Missouri in 1999 and has been working in the St. Louis region since 2005. MoDOT complies with a 1966 Historical Preservation law that requires, before construction money is spent, that nothing historically important has been destroyed. He has a staff of 8-9 archeologists plus university students in the summer. Mr. Meyer said there have been two bridge projects, first the new Mississippi River bridge (Stan Musiel

Bridge) and then the Poplar Street bridge project, off and on since 2013 (see Page 2 for details). The Poplar Street bridge is located in the oldest part of St. Louis which has French Colonial history dating back to the 1770s and some before 1766. He circulated interesting artifacts, some of which are pictured, which were found at this

site.



INTRODUCTION

The MoDOT Historic Preservation Section began conducting archaeological investigations in 2013 for proposed highway improvements in downtown St. Louis. The construction project is situated on the periphery of the Jefferson National Expansion Memorial and coincides with the location of the original village of St. Louis as platted in 1764. Although a preliminary analysis of the project area conducted in 2012 concluded that there was some potential for locating late-eighteenth century deposits, the actual results have been far more impressive.

THE EARLY YEARS OF ST. LOUIS

Excavation not only identified features associated with the mid-nineteenth century occupation of the area, but also remnants of three of the original French homes built in the 1770s. Results of the 2013 field season indicate that portions of two sites, the Madam Haycraft Site and the Louis Beaudoin Site, contain stratified cultural deposits dating to the French founding of the city. The discovery of the houses owned by Joseph Bouchard, Simon Coussot, and Louis Beaudoin, as well as associated features, provides hope that more evidence of the old French village will be uncovered.

Archaeological excavations of both the Haycraft and Beaudoin Sites are ongoing, and it anticipated that additional of the evidence early occupation of St. Louis will be discovered in the coming Perhaps months. more importantly, however, it is expected that at the conclusion of the latest round of highway construction, intact remains of the French occupation of

St. Louis will be safely encapsulated and preserved under pavement within MoDOT's right of way.

PUBLIC BENEFIT

A report will be prepared (which will be available to the public) and professional papers will be presented, discussing various aspects of the site and of the excavation. In addition, an attempt will be made to publicly display artifacts recovered from the site in partnership with the National Park Service.

COMPATRIOT BOYD BISSELL ON GENERAL DANIEL BISSELL AND FORT BELLE FONTAINE PARK

Although Boyd is not a direct descendant, General Daniel Bissell was a member of Boyd's Bissell family. General Bissell began his military career in the Connecticut State Militia as a fifer during the American Revolution. Following the war, Bissell became an officer in the United

States Army on April 11, 1792. After several promotions he took command on May 20, 1809 of Fort Belle Fontaine in St. Louis, the first military fort west of the Mississippi River. On August 15, 1812, he was appointed to command the 5th Infantry Regiment with the rank of colonel. Daniel Bissell served with



distinction during the War of 1812 and was promoted to brigadier general on March 9, 1814. He commanded U.S. forces at the Battle of Cook's Mill on

October 19, 1814. This minor battle was one of the few American land victories of the war. Boyd was provided a large stack of transcribed letters (see examples in photo) beginning in 1812 by the professor who oversees Fort Belle Fontaine Park in St. Louis, Missouri.

Fort Belle Fontaine established in 1805 has a long, interesting history. The site, named a St. Louis Park in 1986, covers more than 293 acres. It served as a launching or stop point for expeditions to the far-reaching American West. Captains Lewis and Clark and members of their "Corps of Discovery" camped across the river from this site at the start of their voyage on May 14, 1804 and camped at the fort on the last night of their journey on September 22, 1806. The land includes several structures with historical significance. The Works Progress Administration built limestone projects including the Grand Staircase between 1936-40 to enhance the Missouri Hills Home estate at the Park to attract visitors to the picturesque landscape. The Grand Staircase was shored up in 2011 using approximately 736 tons of rock costing \$12,414. On August 11, 2005 the area was certified as a Lewis and Clark Natural Heritage Site, an honor bestowed to only ten areas in the State of Missouri. The park is open from 8 a.m. until sunset with self-guided tours of the Grand Staircase and guided tours by appointment (314-544-5714). The park containing General Daniel Bissell House is also open to the public from 8 a.m. until half an hour after sunset and the house has guided tours by appointment (314-615-8800). A Google map of the the fort location and of General Bissell's house is attached.





WREATHS ACROSS AMERICA - MISSOURI VETERANS CEMETERY JACKSONVILLE, MISSOURI



President Larry Potter and his wife, Terrie, represented the Braxton C. Pollard Chapter, Sons of the American Revolution, at this special event held last Saturday which Potter called a humbling experience.

The following history is from Wikipedia: Morrill Worcester, owner of Worcester Wreath Company of Harrington, Maine, was a 12 year old paper boy for the *Bangor Daily News* when he won a trip to Washington D.C. His first trip to our nation's capital was one he would never forget, and Arlington National Cemetery made an

especially indelible impression on him. This experience followed him throughout his life and successful career, reminding him that his good fortune was due, in large part, to the values of this nation and the veterans who made the ultimate sacrifice for their country.

In 1992, Worcester Wreath found themselves with a surplus of wreaths nearing the end of the holiday season. Remembering his boyhood experience at Arlington, Worcester realized he had an opportunity to honor our country's veterans. With the aid of Maine Senator Olympia Snowe, arrangements were made for the wreaths to be placed at Arlington in one of the older sections of the cemetery that had been receiving fewer visitors with each passing year.

As plans were underway, a number of other individuals and organizations stepped up to help. James Prout, owner of local trucking company Blue Bird Ranch, Inc., generously provided transportation all the way to Virginia. Volunteers from the local American Legion and VFW Posts gathered with members of the community to decorate each wreath with traditional red, hand-tied bows. Members of the Maine State Society of Washington, D.C. helped to organize the wreath-laying, which included a special ceremony at the Tomb of the Unknown Soldier.

The annual tribute went on quietly for several years, until 2005, when a photo of the stones at Arlington, adorned with wreaths and covered in snow, circulated around the internet. Suddenly, the project received national attention. Thousands of requests poured in from all over the country from people wanting to help with Arlington, to emulate the Arlington project at their National and State cemeteries, or to simply share their stories and thank Morrill Worcester for honoring our nation's heroes.
