Founding and Chartering of the Fernando de Leyba Chapter

Sometime in 1995 James (Jim) L. R. Boyd, Jr. and Richard (Dick) H. Hofer, Sr., members of the Spirit of St. Louis SAR Chapter, set about to organize an SAR Chapter in the St. Charles area. Jim Boyd was the Organizing President. The organizing effort extended throughout 1996 and early 1997.

The nucleus was members of the Spirit of St. Louis Chapter in St. Louis, some of whom lived in the St. Charles area. Others liked the idea of an evening meeting rather than a Saturday morning meeting. Recruitment began to find potential members from the area to reach the chartering quota. The Missouri SAR Society Bylaws required 15 members to form a chapter or the approval by the Missouri Society, SAR Board of Directors if less than 15.

The chartering ceremony took place on Sunday, May 4, 1997 at Pio's Restaurant in St. Charles. The speaker at the Charting Meeting was State Senator Steve Ehlmann. It was decided that Charter Members would be those who joined the Chapter during 1997 and 1998. At the time of the chartering, there were 19 members; including 6 Dual Members. During 1998, 4 more members were added. The 23 Charter Members were the following men.

It took 108 years after the founding of the SAR for St. Charles, Missouri to have an SAR Chapter. Better late than never. -- We are thankful that the Spirit of St. Louis SAR Chapter spent the time and effort to start the Fernando de Leyba SAR Chapter.

Naming of the Chapter

The following information was provided by Compatriot Edward (Ed) S. Gray, Charter Member of the Fernando de Leyba Chapter. Ed has served as MOSSAR President (1992-1993), NSSAR VPG Foreign District - Western Hemisphere (1996) and NSSAR South-Central District VPG (2003). He received the NSSAR Minuteman Award in 2000.

"Gary William Beahan, who was then a member of the Christopher Casey Chapter and also the State Archivist, made an excellent presentation on the Battle of Fort San Carlos and talked at length about Fernando De Leyba and all the problems he had rallying the people of the then sleepy little village of St. Louis. He had problems with alcohol and was actually dying at the time, but he successfully defeated the combined English/Northern Woodland Indians during May, 1780. Gary later took me to the State Capitol and showed me the painting of the fight in the gallery of Missouri.

James L.R. Boyd, Jr., the organizing President of the Fernando de Leyba Chapter, called me and asked what I thought of some of the names being considered for the Chapter. I remember that he reported that someone suggested that they name it "Spirit of St. Charles." I reminded him that was a tour boat at the riverfront of St. Charles (owned by the same people who had Noah's Ark Restaurant in St. Charles). It was later sold to some interests in Louisville, was renamed "Spirit of Louisville" and was hit by a passing barge and sank at its moorings. Someone suggested naming it after their ancestor. I told James about the problems we had with naming a chapter after their ancestor and we decided that was not the route to go.

Having just heard and seen the evidence about Fernando de Leyba, Deputy Governor of the Spanish Territory of Louisiana, I suggested to Compatriot Boyd that his name be considered. He took that to the membership and they voted in the affirmative for that name. It was then approved by the MOSSAR Board of Directors at their next quarterly meeting. The Chapter was chartered with this name.

And as one of my favorite radio commentators would say...."Now you know the rest of the story!"

Chapter Namesake

Don Fernando de Leyba was appointed governor of Upper Louisiana in June 1778. Though Spain was neutral until 1779, Fernando de Leyba contacted George Rogers Clark prior to this and provided support to the Americans. Fernando de Leyba was responsible for the construction of Fort San Carlos to defend St. Louis. The British, along with Native American allies, attacked on May 26, 1780 but were forced to retreat. We remember the crucial and not widely known support of the American Revolution received from Spain and honored it by naming our Chapter after Fernando de Leyba.

Battle of Fort San Carlos

In July, 1779, Spain joined the American Revolutionary War against Great Britain. Great Britain had ordered its generals in Canada to begin expeditions against Spanish settlements on the Mississippi River a few weeks before this. Their mission was to drive out the rebels led by George Rogers Clark and take control of St. Louis and the Mississippi River. George Rogers Clark learned of this and warned the Spanish Commandant at Saint Louis, Fernando de Leyba, in March 1780 to prepare for an attack. Fernando de Leyba began fortifying the village. With money from the villagers and his own resources, and with volunteer labor, he began to construct a tower, which we call Fort San Carlos, at what is now the intersection of 4th and Walnut Streets in St. Louis. He also had the villagers dig a mile-long trench from each side of the tower to the riverbank. The area includes the area at Ball Park Village where an SAR plaque has been placed. The Spanish brought cannons to place in the tower from an abandoned fort. Men as far away as the Cuivre River (Lincoln County) came to St. Louis to participate in the defense of St. Louis.

Around 1:00 p.m. on May 26, 1780 the large force of Indians, fur traders and seasoned troops under British command attacked the village. These attackers found the village to be protected by the tower and about 200 armed defenders. However, some villagers were surprised working in the fields, and about 25 were killed and 70 captured. The cannon fire alarmed the Indians and they withdrew. The British western campaign failed. The village of Saint Louis was never attacked again. The same day George Rogers Clark and his army defeated the British at Cahokia.

The Battle of Fort San Carlos is the furthest west recognized battle of the American Revolution.



Chapter Growth and Membership

The Chapter has had a continued membership growth over the past 22 years. Since May 4, 1997 through December 31, 2018, 135 men (including Junior Members and Dual Members) have been members of the Fernando de Leyba Chapter. Of that 135, 21 are deceased, 23 dropped their FDL and/or SAR membership, and 5 transferred out leaving 86 current members (full, junior, and dual), as of December 31, 2018.

Of the 135 men, 111 obtained SAR membership through the Fernando de Leyba Chapter. 24 men had SAR membership prior to joining the Fernando de Leyba Chapter.

With regard to the 23 Members who have dropped their FDL and/or SAR membership:

- 13 of the 23 dropped after the first year.
- 4 of the 23 dropped after the second year.
- 6 of the 23 dropped for other reasons.

There are 3 Charter Members (who were Dual Members) that have dropped their Fernando de Leyba Chapter membership. There are 2 Charter Members (who are Dual Members from other Chapters in the State) that have been members the entire 22 years of the Chapter's existence. They are Dr. Jerrell L. Driver (ALO) of Jackson, Missouri and Edward S. Gray (MAL) of Jefferson City, Missouri.

Chapter Meetings

The Fernando de Leyba Chapter has met in four locations to date. The Chapter first held its monthly meetings in the meeting room at Wiliker's Restaurant & Bar located at 1566 Country Club Plaza Drive in St. Charles (1997- September 2008). The second meeting location was in the meeting room of Culpepper's Grill & Bar located at 3010 West Clay Street, St. Charles (October 2008 – December 2017). The third meeting location was in the community meeting room at Schnuck Market (Schnucks Zumbehl) located at 1950 Zumbehl Road, St. Charles (January 2018 – September 2018). The fourth and current meeting location is a meeting room at Embassy Suites by Hilton St. Louis in St. Charles, 2 Convention Center Plaza, St Charles (starting October 2018).

Spouses of members are always welcome to attend the Chapter meetings, as are prospective members and their spouses. Compatriots usually start arriving between 6:00 and 6:30 p.m. and have an informal dinner and socialize. The meeting starts at 7:00 and usually lasts no longer than two hours. The meeting typically consists of a business session including reports, awards, swearing in new members, presenting supplementals, and a presentation on a topic by either a Chapter Member or an outside guest. In April or May of each year the Nathan Futrell Society of the Children of the American Revolution (C.A.R.), which is sponsored by the Chapter, presents a program of their activities for the past year.

Color Guard

Over the past 22 years a number of Compatriots have uniforms and participate in Color Guard activities. The Chapter Color Guard Members are very active. The current Eastern Missouri District Color Guard Commander and Chapter Color Guard Commander is Chapter Member William (Bill) A.G. Grote. The Color Guard's purpose is to teach about the American Revolution by displaying the various uniforms of our Patriots and honoring the flag of our country. The Color Guard is made up of both Continental Army and militia uniforms. Members try to be as authentic as possible with their uniforms. The Chapter Color Guard Members are a part of the Missouri SAR Society Color Guard. They are available for parades, Patriot and Compatriot grave markings, funerals, ceremonial functions, living history events, school events and lectures, DAR events, and other activities in the area and around the State. The Fernando de Leyba Chapter performs a musket salute whenever possible. The Chapter Color Guard Commanders have been Stuart (Stu) L. Ballou, Ray E. (Ed) Morris, William (Bill) A.G. Grote.

Charter Member Edward (Ed) S. Gray donated a musket to the Chapter in 2012, which can be used for ceremonies but cannot be fired. In 2014 Chapter Member Jonathan (Jon) D. Hunt donated 2 muskets to the Chapter. In 2018 Compatriot Hunt donated 3 additional muskets; one is a replica/non-firing and 2 can be fired. In summary, the Chapter has 6 muskets of which 4 can be fired and 2 cannot be fired.

Nathan Futrell Society, Children of the American Revolution (C.A.R.)

The Chapter sponsors and supports the Nathan Futrell Society of the Children of the American Revolution (C.A.R.). The Nathan Futrell Society is one of 15 C.A.R. societies in Missouri. The Nathan Futrell Society attends a Fernando de Leyba Chapter meeting annually in April or May to present a program about what they have done during the past year. They meet the second Tuesday of each month at 7:00 p.m. They have an Online Book Club the first Thursday of each month at 7:00 p.m. They participate in the annual State meeting and in planned events. They participate in the annual 4th of July Parade in St. Charles.

Programs and Awards

The Chapter has been very active in the SAR Youth Programs. The Chapter has had the State Level Americanism Poster Contest winner twice, the brochure contest winner twice, the Knight Essay winner twice, the M. Graham Clark Elementary Teacher of the Year twice, and the M. Graham Clark High School American History Teacher of the Year twice. The Chapter has presented medals and/or certificates and/or cash awards to JROTC Cadets, Naval Sea Cadets, and Eagle Scouts but none were not selected for first place at the Missouri Society level.

The Chapter has been very active in presenting community awards. Each year the Chapter strives to recognize those that serve the St. Charles City and County community. Multiple Law Enforcement Medals and Certificates, Fire Safety Commendation Medals and Certificates, Emergency Medical Service Medals and Certificates, and Heroism Medals and Certificates have been presented.

The Chapter strives to recognize DAR Members, spouses, and other women that provide assistance in the Chapter's programs and recruiting new SAR Members.

The Chapter presents award medals and certificates to its members, including the NSSAR Membership Pins and Military Service Medals.

Since November 2013, the Chapter has joined with the Saint Charles Chapter of the Daughters of the American Revolution (DAR) in volunteering to work at a concession stand at the Family Arena in St. Charles to raise funds for supporting the Chapter's Youth Awards, Community Awards, and Chapter Awards Programs.

In 2014 Chapter Member Jonathan Hunt donated funds to create the "Pvt. Jonathan Hunt Memorial Fund" to support the financial awards of the Chapter's Youth Programs for a 10-year period. There is a requirement that the Chapter participate in each financial award given.

At the 126th NSSAR Congress in 2016 (July 8-13, 2016) the Fernando de Leyba Chapter received the President General's Cup Certificate for 2015, which is given to the National level chapter, based upon size, presenting evidence of the most complete program of activities. At the 128th NSSAR Congress in 2018 (July 11-19, July 2018), the Chapter received the award again.

The Chapter received the Missouri Society Annual Josiah Fogg Award six (6) times; once as a small chapter in 2005 and five (5) times as a large chapter in 2011, 2013, 2014, 2015, and 2016.

The Chapter received the Missouri Society Annual Yohe Chapter Yearbook First Place Award four (4) times in 2012, 2013, 2014, and 2017 (tied with OMC). Notwithstanding that the Chapter did not receive first place in 2015 and 2016, we believe the Chapter had outstanding yearbooks for those years.

The Chapter received the first-place award for presenting the most NSSAR Flag Commendation Certificates for the years 2016 and 2017.

The Chapter received the Missouri Society level Annual Americanism First Place Award three out of four times that the State has participated. The Chapter won the Missouri Society Americanism First Place Award for 2014, 2015 and 2016.


Chapter Website, Facebook, and YouTube

The Community Tab includes information about the Youth Programs/Contests. The Video Tab takes you to a Fernando de Leyba Chapter YouTube site, which includes Chapter meeting presentations and links to other videos of interest. The Members Tab includes current and past Chapter Newsletters (the "Cannoneer"), a listing of current Chapter Members along with their documented SAR Patriots, and a listing of deceased members. The Links Tab includes Organizations, Genealogy, (sources for) Uniforms and Accessories, American History, Travel (American Revolution Sites), Support Us, and a MOSSAR Presentation by Compatriots Dave Hill and Matt Swanson on "How to make your chapter standout by using a Website and Facebook".

The Chapter commissioned the creation of a custom painting of U.S. Navy ships named


Missouri. The painting was placed on the current USS Missouri, a fast attack nuclear submarine. The artist was Ken Martin of St. Peters, Missouri.

The Missouri Sons of the American Revolution commissioned St. Charles County artist, Ken Martin, to create a painting of the newest *USS Missouri*. Preceded by four other vessels of the same name, the latest *USS Missouri* is a Virginia Class Nuclear Attack Submarine. The official commissioning of the vessel was held at the New London Naval Submarine Base in Groton, CT on 31 July, 2010. The painting was presented to Commander Timothy Rexrode prior to the commissioning ceremony by officers of the Fernando de Leyba Chapter of the Missouri Society, SAR. It will hang on the wardroom bulkhead aboard the *USS Missouri, SSN - 780*.

The previous vessels which carried the same name were; *The USS Missouri, circa 1847* - a 10-gun side-wheel, steam-assisted frigate, *The USS Missouri, circa 1863* - a Confederate side-wheel ram which operated on the Red River in Texas before surrendering to Union forces, *The USS Missouri, circa 1906*, a Maine class battleship which sailed around the world with the "Great White Fleet" and the *USS Missouri, circa 1944* - "Mighty Mo" who secured her place in history when MacArthur accepted the surrender of the Japanese forces aboard on 14 August, 1945.

In 2008, Ken Martin was selected by U.S. Representative and Compatriot Todd Akin, to create an ornament representing Missouri's 2nd District for the White House Christmas Tree. The ornament had as it's theme "Missouri's River Boats" and depicted The Lewis & Clark Discovery Boat, a James B. Eads Civil War Ironclad and *The Bright Star*, a Missouri River Packet Steamer. The Fernando de Leyba Chapter became aware of the ornament and invited Martin to come and speak at a Chapter meeting about the project. They then decided to commission Martin to do a painting representing the five historic vessels which have carried the name, "The USS Missouri".

The Chapter participated before and after the National Society approved the Annual Commemoration of the Battle of Fort San Carlos in St. Louis as an NSSAR Annual Historic Sites and Celebrations Event ("National Color Guard Event"). Based on information gathered by Dennis J. Hahn (FDL) and William (Bill) L. Groth, Jr. (SSL), Compatriot Hahn (FDL) prepared a presentation and Chapter Member Charles E. Lilly (FDL) made the presentation to the NSSAR Historic Sites and Celebrations Committee at the NSSAR Fall Leadership Meeting on September 27, 2013. The Committee approved the event to become a NSSAR Annual Historic Sites and Celebrations Event. The first approved event was held on May 25, 2014.

The Chapter participated in the placing by the Missouri Society a plaque near Busch Stadium at Ball Park Village commemorating the Battle of Fort San Carlos. The Chapter participated in the placing of a plaque by the Missouri Society with Lindenwood University in St. Charles and the Daniel Boone Home in Defiance at the Boone Home honoring Patriot Daniel Boone on May 17, 2015. MOSSAR President Robert J. Corum participated in the


