#### **Missouri Society Secretary - Duties**

The Office of the State Secretary is established in Article Four – Officers and Board of Directors – in the Constitution of The Missouri Society of the Sons of the American Revolution as adopted 28 April 1990 and amended 30 January 2021. The Duties of the State Secretary are delineated in Article Six, Section 4, of the Missouri Society, SAR, By-Laws as amended on 27 March 2021. The following paragraphs expand on the duties and responsibilities of the State Secretary regarding Standard Operating Procedures.

The Secretary is notified of all new members of the Missouri Society, SAR, by a transmittal from the Registrar General, NSSAR. The transmittal gives the name of the member, his address, date of registration and National Number. A record copy of the new members application accompanies the transmittal, as well as the membership certificate and a Record Copy for the new member. The Secretary records the following information in the State Number Database: the members name, address, National Number, date sent to the State President, date sent to the State Registrar and Genealogist, the member's Patriot Ancestor, and the member's State Chapter affiliation. In addition, the Secretary assigns the State Number for the new member. The State Number is recorded on the Secretary's copy of the Record Copy and the member's copy of the Record Copy. The Secretary

signs the membership certificate and makes arrangements for the State President to sign the membership certificate. The signature of the State President may be obtained mailing the membership certificate and associated documents to the State President or by using a signature stamp provided by the State President. The membership certificate, member's copy of the Record Copy and other associated documents are sent to the Chapter President of the new member's chapter affiliation. The Secretary sends a copy of the transmittal form from the Registrar General, NSSAR, and the new member's Record Copy to the State Registrar and State Genealogist. Scans of these documents may be made and transmitted to the Registrar and Genealogist by email. The original transmittal form and Record Copy are retained by the Secretary and filed in a manner that allows for retrieval, if necessary. It is convenient for the Secretary to supply the State Genealogist with a signature stamp because all NSSAR membership applications must be signed by the State Secretary.

The Secretary is notified of all Supplementals for members of the Missouri Society, SAR, by a transmittal from the Registrar General, NSSAR. The Supplemental transmittal contains the name of the member, the Patriot Ancestor through whom the supplemental was approved, the date of registration and the National Number. The process outlined above for new members is essentially the same as with Supplementals, except the State Number of the member has been assigned previously. The Supplemental transmittal is accompanied by a Record Copy and Supplemental Certificate. The Certificate requires no signatures of State Officers. The Record Copy is retained by the Secretary and filed in a manner that allows for retrieval, if necessary.

The Secretary receives a transmittal from the Registrar General, NSSAR, for changes in membership status, which might include, but is not limited to, Reinstatement and Transfers into or out of the Missouri

Society, SAR. Processing these transmittals includes, but is not limited to, sending the transmittal form, and associated documents to the State Registrar and State Genealogist. There is some variation in Standard Operating Procedure depending upon the specifics of the change in membership.

The Secretary records the minutes of the meetings of the Executive Committee, the Board of Directors and other group meetings than may transpire during his tenure. These minutes are prepared in typed format and may be sent to State Officers, Honorary Vice Presidents, Chapter Presidents and Committee Chairperson, depending upon the group from which the minutes were recorded. The Secretary retains a printed copy, or an electronic copy of all minutes and they are filed in a manner that allows retrieval, if necessary.

The Secretary is responsible for sending minutes, notices of meetings and other materials and documents as directed by State Officers, including the President, Executive Vice President, 1<sup>st</sup> Vice President, 2<sup>nd</sup> Vice President, Registrar, Treasurer and Genealogist. The Secretary may receive these materials and documents by mail, email, or text message; hence, the Secretary must have computer skills sufficient to manage these forms of communication. Prior to each Quarterly Meeting the Secretary sends a request to all Officers, Honorary Vice Presidents, Chapter Presidents and Committee Chairpersons to submit a report of their activities and actions for the quarter to be received at least one week in advance of the Quarterly Meeting. The Quarterly Reports are compiled by the Secretary and sent to all Officers, Honorary Vice Presidents, Chapter Presidents and Committee Chairpersons.

The Secretary is responsible for a Roll Call for all meetings and the Roll Call should list all Missouri Society, SAR, Officers, Honorary Vice Presidents, Chapter Presidents and Committee Chairperson. The Standard Operating Procedure for a Roll Call is to name the Officers first

and the Chapter Presidents second to secure a quorum. If Officers and Chapter Presidents are not in sufficient number to establish a quorum, the Honorary Vice Presidents are called. The Committee Chairpersons are not members of the Executive Committee or the Board of Directors, hence, they cannot be used to establish a quorum. The Secretary is a member of the Executive Committee and the Board of Directors.

The Secretary must complete the NSSAR Youth Protection Training Course (YPTC) and receive and maintain a valid Certificate of Completion. The YPTC is accessed through the NSSAR website.

The Secretary must maintain the USPS mailing address of all Chapter Presidents and the email address of all Officers, Honorary Vice Presidents, Chapter Presidents and MOSSAR Committee Chairpersons. Email addresses may be provided by other State Officers or Honorary Vice Presidents. The Secretary may be assigned or delegated other duties at the request of the State President.

#### **Missouri Society Treasurer - Functions**

Act as the signatory for the society, and as the primary contact for the bank and investment accounts, maintain account passwords and checkbooks, receive all correspondence associated with such accounts, and receive and write checks on behalf of the society. It is preferred to use a business account for banking, with a deposit stamp, rather than a personal account. During COVID-19, mobile banking has been the preferred method for depositing checks. Cash should be deposited as quickly as possible.

#### **Accounting**

Maintain a general ledge and a chart of accounts, suitable to generate a standard set of financial statements on a quarterly basis. It is preferred to close accounts monthly. Accrual accounting is preferred to cash accounting. Retain support for transactions.

The number of transactions does not require the use of accounting software. Instead, the general ledger and journals can be maintained in excel.

#### Recordkeeping

All records are currently maintained electronically. Records include correspondence, support for transactions, and all account statements. They are saved in PDF Format, and cross referenced with general ledger entries. By keeping all records in electronic format, they can easily be audited and passed to the next treasurer. Backup copies should be retained.

#### Insurance

Act as the primary contact for the insurance broker, pay insurance premiums, and forward copies of insurance certificates and policies to the secretary. Ensure that the insurance provider has an updated list of officers for insurance. The broker should be contacted in mid-Q2, and premiums are usually due in Q3.

#### Tax

File Form 990-N with the IRS on behalf of the Society. Contact chapters to ensure that each chapter also files their local 990-N. The e-postcard version of the form may be filed on-line, and is due every year by May 15th. Maintain all tax records and filing instructions. As described above, these are retained electronically.

#### Dues Collection & amp; Reconciliation

In September of every year, the Treasurer receives an updated roster from the Registrar. This roster is received in excel format. This is used to prepare a separate roster for each chapter treasurer to use for dues collection. The treasurer contacts each chapter treasurer and president to provide instructions and rosters for dues collection. The same information must be provided to the executive vice president, who conducts dues collection for members at large.

Throughout September and Q4, the treasurer will receive dues payments and paid-member lists from chapters. Use this to maintain a master list (in excel format) of payment status for all members. Deposit dues payments, which are in the form of monthly totals from chapters and maintain an accrual for the liability that will be due to NSSAR for national dues.

In January, provide dues payment information to the Registrar and reconcile any discrepancies.

Together with the registrar, then complete NSSAR reconciliation forms and issue national dues payment to NSSAR.

#### Membership Cards

Concurrently distributing chapter rosters and instructions for dues collection, the treasurer also sends membership cards to chapter treasurers. Many chapters use these cards when requesting dues payment, so distribution in early September is important.

Dues cards are printed on standard business card stock, although a printing service through a business supply store is a best practice. The

membership cards should be formatted through a mail merge with the roster.

#### Member Reinstatement

Throughout the year, the treasurer will receive reinstatement payments. The treasurer must coordinate the completion of form 0918 with the Registrar, and then issue payment to NSSAR.

The treasurer should maintain a list of all reinstatement payments that are processed and communicate regularly with the Registrar on the status of the list.

#### **Eagle Scout Recognition Program Procedures and Guidelines**

One of the goals of our organization is to recognize those young men and women who attain the rank of Eagle Scout. This is the highest rank that a youth in Scouting can earn. It is a very demanding and lengthy process to earn the Eagle Scout Rank. Less than 10% of all Scouts ever earn the rank of Eagle Scout. These youth are worthy of our recognition and respect. In Missouri we have had a long tradition of recognizing those who attain the rank of Eagle Scout. If your chapter is approached by a Troop or individual asking for an Eagle Scout Court of Honor presentation and certificate of recognition my goal is to make it as easy for you to have the appropriate certificate and letter for your presentation. Many chapters do this in revolutionary era uniforms, and many color guards help the Scouts by participating in the presentation of the colors. Gather the information you will need to have the certificate and letter to be completed. i.e., Name, Troop Number, Date of Court of

Honor or Date Eagle Scout Board of Review. Once you have gathered this information then forward it to me and I will return to you an Eagle Scout Certificate of Recognition and a congratulatory letter to the Eagle Scout. My contact information is: Gary D Gift, 3725 South Forest Ave, Springfield, MO 65807 (417)860-5886 gary.gift@hotmail.com Contact the Scoutmaster or the Court of Honor planner and determine your chapters requested level of participation. This is a great opportunity for the Chapter Color Guard to participate in the opening flag ceremony. It is a good idea to show up a little early so that any final changes in the agenda can be worked and to allow photos with the recipients (especially if the presenters are in uniform). I would also recommend that your chapter strongly encourage participation in this program and if asked. This program is a great way to increase the visibility of your chapter's community outreach. Many units are not aware that we offer this recognition. Once your chapter has done a few it will become a popular request.

Contact your local Scout Council and Troops to let them know about the Arthur M and Berdina King Eagle Scout Contest and encourage Eagle scouts to participate. Many Councils and Units are not aware of the contest. The deadline for a chapter to complete a competition is December 31<sup>st</sup>. Chapter winners should be sent to me by the state deadline of January 15<sup>th</sup>. A winner will be selected by a committee of judges from several chapters. The deadline for all State winners to be submitted to National SAR Eagle Scout Committee is February 15<sup>th</sup>. state winner will be announced at the first quarter meeting with presentation to the State Winner at State Annual Meeting in April. National winner will be selected at the Spring Leadership Meeting in Louisville and will be announced and presented at the National Congress in July. All chapter applications will need to be sent to me either by mail to Gary D Gift, 3725 South Forest Ave, Springfield, MO 65807 or emailed to me at garv.gift@hotmail.com The application and four generation ancestor

chart and essay topic and examples of previous winning essays can be found on the National SAR website, or on the State SAR website in a link to the Manual of Operations. The application and four generation ancestor charts are both in a fillable PDF format which should make them easier to complete. Please encourage applicants to attach an additional page to the application if they need more room to accurately document their achievements.

#### **Arthur M. & Berdena King Eagle Scout Contest**

Missouri President George Swales has asked me to serve as the state chairman for the Arthur M & Berneda King Eagle Scout Contest committee. This is a great opportunity for the Eagle Scouts in our state. We have had several first place \$10,000 award winners from our state and last year our state winner came in first in the national contest. The awards can either be taken as a cash award or as a scholarship to an educational institution. Last years winner was Eagle Scout Logan Matthews and his application was sponsored by the Christopher Casey Chapter. Congratulations Logan and a big thank you to the Christopher Casey Chapter for sponsoring such a wonderful candidate. I would encourage all chapters to conduct a contest and sponsor an Eagle Scout Contest application. We would love to get an application this year from each chapter in the state.

Below are the rules from the National Society of the Sons of the American Revolution.

The National Society of the Sons of the American Revolution (SAR) invites all Eagle Scouts interested in the American Revolution to participate in the Arthur M. & Berdena King Eagle Scout Contest. The contest is open to all Eagle Scouts who are currently registered in an active unit and, except as provided in the paragraph below, have not

reached their nineteenth birthday during the year of application. The year that the Eagle rank was awarded is not restricted.

Temporary Transition Rules Extension – Any youth who registered as a member of Scouts BSA between February 1, 2019, and December 1, 2019 and was granted an extension by the National Council BSA to complete the Eagle Scout rank requirements after they have turned 18 years of age, will have 365 days from the date their Eagle Scout application was validated by the National Advancement Program Team to enter the contest. A copy of the approved extension must be attached to the contest application. College plans do not have to be completed in order to receive the awards.

Three awards are given: National First Place Winner receives \$10,000; Runner-up receives \$6,000; and 2nd Runner-up receives \$4,000. The First Place Winner will be asked to appear at the SAR Annual Congress, held in June or July, to be recognized and receive the award. The awards may be taken as either a cash award, or as a scholarship to an educational institution. An Eagle Scout may apply for the contest in more than one year if they meet the age requirements, but no more than \$10,000 total will be awarded to any one Eagle Scout. Prizes and recognition may also be awarded at the SAR Chapter and State Society level. Each Eagle Scout must complete an application form, a fourgeneration ancestor chart, and a 500-word patriotic themed essay.

The competition is conducted in three phases: the local Chapter level, State Society level, and National level. The competition is usually entered at the Chapter level, though in some cases, the competition may be entered at the State Society level. Applicants may not enter at the National level. Contest entrants need complete only one application for the SAR Chapter level competition. The application of the Chapter level winner is forwarded to be used in State Society and National level competitions by the SAR as appropriate. A complete set of rules, along with the application for both the applicant and the sponsoring SAR

members, can be found on the Eagle Scout Application Form available for download on the link below. Please be aware that the local application deadline dates may vary, so interested applicants should reach out to the local SAR State Eagle Scout contact listed below for further detail.

The applications should be due to your chapter contest chairman by December 31,2020. All applications will be due to me by January 15,2021. The state committee will then judge the state winner so that we can submit it to national to be judged at the spring leadership meeting in February. I look forward to the applications we get this year. The candidates from Missouri have always been some of the best in the country and I am excited to see what we have this year. Please start looking and working with your local Boy Scout Council to acquire a quality candidate. Remember girls now have the ability to earn the Eagle Scout Rank so female Eagle Scout are also eligible for this award.

#### Sons of the American Revolution Yohe Yearbook Award Requirements

The purpose of the Lloyd Yohe Award is to present chapters' record of support to the mission and goals of the Sons of the American Revolution. The Yearbook is a record of chapter events and activities.

Below are the guidelines for our Missouri SAR Lloyd Yohe Yearbook Award.

- 1. The yearbook should contain appropriate miscellaneous items such as articles from published documents, photographs, programs, place cards, etc.
- 2. The Outside Cover will show the State and National Society name along with the Chapter name, location of the chapter, and the year of the yearbook.
- 3. A Blank page will be placed inside the front cover, and another Blank page will precede the back cover.
- 4. Prepare a Table of Contents page and place it appropriately in the front of the book.
- 5. The next page will contain the current National President General's photograph and his biography. This is to be followed by one containing similar information for the current Missouri SAR President. The chapter

- President's picture and biography will be placed next. A list of the current officers and their office will follow.
- 6. Arrange materials in two main sections, statewide items and chapter items. (PLEASE IDENTIFY PEOPLE IN THE PICTURES). It is not necessary to include duplicate items in both sections.
- 7. Enter items in chronological order in each section. Publicity items such as programs, images, etc. should be quality copies.
- 8. List the archival organization name and address where the yearbook will be stored for the chapter and member use.
- 9. A CD or DVD and a thumb drive will be prepared of the contents of the yearbook.
- 10. A copy of the DVD will be provided to the Yearbook Chairman one month before the competition date for judging.
- 11. The completed book is a record of your chapter events and activities. It does not need art work as an embellishment.
- 12. The Chapter Yearbooks will be displayed at the beginning of the Annual Membership Meeting and will be based upon close adherence to these requirements.
- 13. Other sanctioned entities relating to SAR may enter and compete in the yearbook award contest as approved by the Missouri SAR Board.
- 14. There are to be three divisions of chapters based upon chapter membership and determined by the Missouri SAR Board at the January Quarterly meeting of the year following.
- 15. The Yearbooks will be judged by judges from outside their respective division at the beginning of the Annual meeting of Missouri SAR. There will be awarded three places for each division, but all non awarded participants will receive a certificate of participation. Judges may award 1-3 points for the yearbook that best represents a record of chapter events and activities.
- 16. Chapter Yearbooks must be turned in to the Yohe Yearbook Chairman before the start of the Annual Missouri SAR meeting to be displayed during the Annual Meeting.
- 17. The awards will be announced during the Annual Meeting of the Missouri SAR.

#### Flag Committee

The MOSSAR Flag Committee is responsible for promoting Chapters to recognize individuals and organizations for properly displaying or retiring the American Flag.

On June 14, 1777, the Second Continental Congress passed a resolution to adopt the United States Flag with 13 Stripes and 13 Stars. While over the years the number of stars has increased with the addition of states into the union, the Flag has remained essentially the same as it did in 1777.

The Sons of the American Revolution recognize the use of the flag to be displayed for patriotic purposes, ceremony and as a symbol of our

national unity. The American Flag is to be respected, revered, and honored by its proper use.

Therefore, if an American Flag has been correctly displayed in accordance with the National Flag Code and National Flag Etiquette, a SAR *Flag Certificate* may be presented to individuals or organizations in recognition for their patriotic service to the community.

In addition, if the American Flag is properly retired in accordance with the National Flag Code and National Flag Etiquette, a SAR *Flag Retirement Certificate* may be presented to individuals or organizations in recognition for the proper honor given to the retirement of the American Flag.

Chapters are encouraged to participate in these National SAR program as this participation brings National SAR recognition to the State Society in the form of a streamer for its flag.

The Chairman of the Flag committee will be responsible for the collection of each Chapters participation data. The chairman will then compile and submit the summary on the award form below to National for the MOSSAR streamer recognition.

The National Flag Awards and requirements for SAR National recognition are listed below.

#### Admiral William R. Furlong Memorial Award

This award is presented annually at the SAR Congress to the state societies that have fulfilled the qualifications during the previous year.

To qualify each state society and at least 50% of its chapters must present at least one NSSAR Flag Certificate to a person or organization who qualifies during the previous calendar year.

State societies are to advise the chairman of the Flag Committee of their qualifications by April 15 each year. Societies that qualify will be selected and their names sent to the President General for awarding.

The first year, a certificate and streamer will be awarded to the state society. The streamer is thirty-six (36) inches in length and one and one-half (1-1/2) inches wide with parallel red, white and blue stripes of equal width with a grommet at the top. Each succeeding year that a society qualifies, it will receive a certificate and a white star one (1) inch in diameter to be placed at the top of the streamer.

#### U.S. Flag Retirement Award

This award is presented annually at the SAR Congress to the state societies that have fulfilled the qualifications during the previous year.

To qualify each state society and at least 50% of its chapters must present at least one NSSAR U.S. Flag Retirement Certificate to a person or organization who qualifies during the previous calendar year.

State societies are to advise the chairman of the Flag Committee of their qualifications by April 15 each year. Societies that qualify will be selected and their names sent to the President General for awarding.

The first year, a certificate and streamer will be awarded to the state society. The streamer is thirty-six (36) inches in length and one and one-half (1-1/2) inches wide with parallel red, white and blue stripes of equal width with a grommet at the top. Each succeeding year that a society

qualifies, it will receive a certificate and a white star one (1) inch in diameter to be placed at the top of the streamer.

## 250th Anniversary of the American Revolution Recognition Program National Society Sons of the American Revolution

Compatriots, it is important for all of Missouri SAR chapters to participate in this program. This program is part of the recommended activities to recognize the 250<sup>th</sup> Anniversary of the American Revolution. Please follow the following guidelines:

Organize a 250<sup>TH</sup> Anniversary Committee.

Designate a Committee Chairman

Organize a program of work supporting the mission of the SAR.

Focus your committee on new commemorative events.

Schedule events as 250<sup>TH</sup> Anniversary events using the commemorative logo.

Plan new historic and educational events that enhance your branding.

Choose sustainable events that you can repeat throughout the 250tl' anniversary.

Schedule the events using key partners, Scouts, veterans, civic clubs, etc.

Keep complete records of all activities and participants to gain recognition.

The recognition program is designed to encourage and recognize those compatriots, chapters and societies that participate in local, state, national and international events which publicly educate, and recognize,

honor, and celebrate the events and heroes of the period surrounding the American Revolution. Participation involves the planning and execution of these events, as well as attendance. The medal covers the celebration of any event's 250th anniversary where said event related directly to acts of resistance to British attempts to coerce the residents in America: from the first Parliamentary Acts protested after the conclusion of the French and Indian Wars, through the armed struggle of the American War for Independence, to the ratification of the Treaty of Paris by the Continental Congress. This therefore will cover any public celebrations in the period from 2014 to 2033. Form may be submitted to cover multiple years and following the first submission be submitted in multiple years, only covering activities since the previous submission. Scorekeeping is the responsibility of each compatriot and awarding authority. You will receive an email authorizing the purchase from merchandising. The guidelines and points are described below.

Awards are based on activity and the awarding of points for each type of activity:

- a. Directing, chairing, or co-chairing an event or sub-committee for the duration of the event. (20 points)
- b. Participation in the planning, financing, promotion or conduct of an event other than directing, chairing, or co-chairing an event. Those that do direct, chair or co-chair and event and serve as a regular member of a committee or sub-committee in a non-leadership role, may also earn points. (10 points)
- c. Attending an Event (3 points) d. Attending an event in Colonial Attire(5 points) >

SAR Members may be awarded the Medals for achieving the following levels.

- a. Bronze Medal: 25 promotion points as certified by his chapter, state, district, or national society.
- b. Silver Medal: Compatriots who earn 60 promotion points as certified by his chapter, state, district, or national society.
- c. Gold Medal: Compatriots who earn 150 promotion points as certified by his chapter, state, district, or national society.

Non-SAR members may also be awarded these medals:

- a. The chapter may present bronze awards to its Partners in Patriotism and may recommend its Partners to the state or national society for higher recognition.
- b. The state and district may present silver awards to its Partners in Patriotism and may recommend its Partners to the national society for higher recognition.
- c. The district or national society may present gold awards to its Partners in Patriotism.

Coin Award. May be awarded to SAR and Non-SAR individuals participating in programs but taking no actual leadership role.

Streamer. Awarded to SAR organizations. The certificate will describe the program for which the award is being made.

Streamers come in three levels based on maximum participation in any one event during the year. Stars will be awarded if re-earned in subsequent years. The Bronze Streamer for an average of 10% participation, the Silver Streamer for an average of 25% participation. or a Gold Streamer for an average of 50% participation.

#### 250th Anniversary Programs

The following programs were initiated by the Compatriots of the Ozark Mountain Chapter SAR to create lasting activities within the region that would have the power to bring knowledge of our America Patriots to the forefront in our communities. The following are brief descriptions of complex programs designed to raise the level of Ozark Mountain Chapter SAR in our community. These programs can be adopted by any chapter in American and modified to serve the SAR mission. People used to be familiar with the initials DAR in Springfield, even if they didn't know anything about the organization and they never heard of the SAR. Now they still know the DAR initials and nothing else while they know that SAR is the organization that is teaching in school rooms, honoring veterans in cemeteries, honoring our first responders and generally a group of patriotic men who are making a difference.

#### **History Explorers**

Provides a community forum to present various aspects of our American History in a unique form in that most presenters are costumed, and the presentations are in five to seven segments. This allows each presenter, beginning with a topical report on something that happened in that time in Revolutionary War History. Each additional presenter offers information about another person or event related to the overall theme of the evening. When the hour has elapsed, we hope that we have interested attendees enough that want to explore history on their own. We make our presentations at a local library auditorium and they have an array of books on the topic we covered so that they can easily find books to explore. Over the last three years of quarterly presentations, we have introduced Alexander Hamilton, The First Five Presidents, Revolutionary Women, Civil War Medicine & the Battle of Wilson's Creek, World War I and the Men of Missouri, Native Americans in Southern Missouri, Henry Schoolcraft Explorers of the White River and Southern Missouri and Revolutionary Patriot Migration to Missouri. This is an opportunity for SAR branding and outreach.

#### **Our Patriots**

Our Patriots are those who are descendants of Revolutionary War Patriots who are buried in Southwest Missouri. Liberty, freedom, and patriotism is the heart of this program designed to give ownership of America to everyone, our youth. We research the descendants of Revolutionary Patriots buried in our area and link them to local community leaders and well-known individuals. Students find this interesting, because it gives them direct way to connect with their past and their country. Our Patriots is important because it engages that promote American history and patriotic endeavors. Genealogy, American History and Law are the only merit badges that we will be offering, however we feel that they may be the most important ones in their portfolio of experience.

#### Patriot Sons & Patriot Daughters

The Sons of the American Revolution have made a diligent effort to locate and mark the graves of those Patriots who served in the American Revolution. I propose that they are only the beginning of the "American Patriot Story." The story that follows the sons and grandsons along with daughters and granddaughters of those brave Americans across North America as they settle the frontier of the Western Reserve and forged west across the Mississippi into the uncharted Louisiana wilderness to build a new nation. A nation founded on the blood of our Patriot Ancestors; a nation settled and tamed by Patriot sons and daughters. The Ozark Mountain Chapter would like to place grave markers on the graves of those sons, grandsons, daughters, and granddaughters of our founding Patriots. We propose a simple three-inch bronze marker with the SAR, wreath and cross in the center surrounded by the words Sons of the American Revolution and the words Patriot Son or Patriot Daughter at the bottom. We ask that you endorse this project and request that you support the striking of these medallions by the Medals & Awards Committee. We also ask that the 250th Anniversary Committee adopt the concept for SAR National use by all chapters. The responsibility for acquiring these medallions will be the 250th Anniversary Committee.

#### **WOLF School Project**

This was chosen as a 250th Anniversary project, because of the degree of work involved and the long-term commitment that we were willing to make. WOLF School is a magnet school program that teaches the brightest 5th graders in our community who have an interest in conservation and the outdoors. We provide classroom training, utilizing costumed individuals who play a variety of historic rolls with a focus on

18th century events. This is a big commitment, because it requires preparation of difficult topics for extremely bright students who you interact with for two hours. The focus of our class time is the connection that all young people have with the founding of our country and those who brought us this free and independent nation. We have discussed the role of First Nations people in the Revolution, Daniel and Nathan Boone, the life of local Patriots in the founding of our city, county, and state, etc. This is an opportunity for SAR branding and outreach.

#### National American History & Founders Month

This is a 250th Anniversary project due to the importance of spreading the influence of American History Education throughout our community and the country. This is a big project that we adopted, because we could and thought that others might be inspired to get involved if they made the effort and saw some success. Our initial step was to get our chapter to adopt the NAIIM commitment and following that took the concept to Missouri SAR where it was unanimously adopted. We then come home to our City, County, School System, Library System, Missouri Senate and House of Representatives along with the Governor of Missouri. We did not stop there in that we asked our Missouri Senators, Roy Blunt, and Claire McCaskill to write a letter of support. All these requests have been met with positive results and we are gathering state and local resolutions supporting National American History Month. Now we must use this tool to reach into the community in new and innovative ways. This is an opportunity for SAR branding and outreach.

#### American Patriot Merit Badge Workshop

This 250<sup>th</sup> Anniversary project is intended to offer our Eagle Scouts with the greatest advantage when applying for the Eagle Scout Cash Award. This is a big commitment; however, we feel that it is especially important to local Scouting over the next few years. We will have an opportunity to serve Scouting while at the same time recruit them for the Eagle Scout Award. As we work with them, we will find additional Scouts who have community service projects that may include activities that promote American history and patriotic endeavors. Genealogy, American History and Law are the only merit badges that we will be offering, however we feel that they may be the most important ones in their portfolio of experience.

#### 250th Anniversary Medal

Chairman -the chapter member who is the primary planner of an event 20 points.

Planning - a chapter member who is involved in planning an event 10 points.

Presenter -a chapter member, who speaks, presents a certificate, etc. 5 points.

Display - a chapter member involved in some form of display for an event 5 points.

Program -a chapter member who supports a program; photographer, donation, etc. 5 points.

Color Guard - a chapter member who attends the program in period dress 5 points.

Attendance - a chapter member who attends the program 3 points.

We keep records for our most active members and for non-members who provide support for our 250th Anniversary Programs on a regular basis.

Bronze Medals are awarded for those earning 25 points.

Silver Medals are awarded for those earning 60 points.

Gold Medals are awarded for those earning 150 points.

Bronze Chapter Streamers are presented for 10% participation at an event.

Silver Chapter Streamers are presented for 25% participation at an event.

Gold Chapter Streamers are presented for 50% participation at an event.

#### Authorization to Purchase Medals

SAR National has adopted 250<sup>th</sup> Anniversary Medals to be awarded to Compatriots who have performed service as part of the 250th Anniversary Committee program of work. Each Missouri Chapter should form a 250th Anniversary Committee and set out activities that can be performed to comply with the national call to perform a program of 250th Anniversary activities.

Members who complete 25 points of service in the 250th Anniversary Program may be approved for the Bronze Medal by having your Chapter President confirm your activity by signing your completed form. You or your chapter may then purchase the Bronze Medal.

Members who complete 60 points in the 250th Anniversary Program must present your application to me for a signature to allow you or your chapter to purchase the Silver Medal.

Members who complete 150 points in the 250th Anniversary Program must present your application to Gary Gift through the <a href="mailto:250anniversaryrecognition@sar.org">250anniversaryrecognition@sar.org</a> for authorization to purchase the Gold Medal.

Please present your Medal Authorization letter to your chapter for authorization to purchase the 250th Anniversary Medals from SAR Merchandise. Please keep your authorization letter as proof that the medal may be purchased in your name.

#### **MOSSAR Pershing Fund**

#### **Yohe Public Safety Award Fund**

The Yohe Public Safety Award Fund was established to provide funding to honor public servants who provide excellence in safety for the citizens. While the initial funding of over \$8,000 was a great start, that amount of money does not provide earnings, under current market rates, to fund the awards. Executive Vice President Michael Robertson

has undertaken a review of this fund and is working to make it viable. Although final plans are not available, information will be presented to enable Missouri Compatriots to contribute to the fund so that a proper level of funding is obtained to provide for future awards.

#### **Color Guard**

Color Guard Organizational and Administrative Purpose & Protocol

Consistent with the National Color Guard mission, the Missouri Society's Color Guard promotes education through demonstration and participation at ceremonial events. As a rule, the SAR does not do reenactment events. The Color Guard is the most recognizable and frequent public-facing element of the SAR. It is a high honor to those who serve in that role. It deserves professionalism, decorum. and instills pride.

State Commander-Appointed by State President and serves at the pleasure of the State President. At the State President's choosing, at any time, the State Color Guard Commander role can be re-assigned to another member of the Color Guard. Serving under the State Color Guard Commander are District Commanders. The state society currently has four districts: Northwest, Southwest` Central. and Eastern.

Uniforms-Color Guard members may wear a suitable uniform of the Revolutionary War era, said uniform being as true to design and appearance as possible. Missouri does not have a single "approved" uniform of any military unit of the war. Most members tend to wear a militia or minuteman style of uniform because of greater flexibility of the components and accoutrements, and a more reasonable cost to acquire.

SAR medals earned by a guardsman may not be won on the uniform at any state or national color guard event.

Color guardsman of the Year-Annually. a member of the Missouri Color Guard is chosen as the State Colorguardsman of the Year. Criteria for consideration include but may not be limited to: 1) event participation points earned in the calendar year 2) participation at the state and chapter level in other roles and capacity 3) participation with either other State or National society color guard events. The candidate must provide an event scoring sheet to qualify. It is preferable that no single. dedicated and committed color guard member receive the award in repeated successive years unless no other state members have demonstrated a level of commitment and dedication commensurate with their available time. One who is still employed should not be discounted out of hand merely on the basis that he was unable to accrue the most points. Color Guard event points must be documentable. A photograph with a summary of the event should be maintained by each member. The member is responsible for tracking points and maintaining documentation of event participation. A Chapter Officer or District Commander may submit the name of the candidate for consideration. Conduct and demeanor should be a level one would ascribe to a person of military rank. When at a public demonstration or ceremony, present a professional appearance, sharp in dress, and smart in formation and execution of commands. Diminishing physical abilities and health may be grounds for suspending formal drill, firing musket, and marching; but otherwise proudly wear the uniform to chapter and state events.

#### **Points & National Events**

The National Color Guard Manual sets forth event point values.

Generally, any chapter event earns 5 points, a state event 10 points, and a national event 20 points. Refer to the SAR manual for details. In January, the National Color Guard issues a list of National Events across

the country that earn national points. The list appears in The Colorguardsman magazine.

#### **Patriotic Education**

INTRODUCTION-The information provided below can be found at the National Society Sons of the American Revolution website www.sar.Qi.g/education/ and has been slightly modified to specifically address applicants submitting their materials to the Missouri Society SAR. Poster, Brochure, Oration` Knight Essay and History Teacher Competitions at the Chapter level are held prior to December 31. Competitions at the State level will be held at the quarterly Missouri Society Meeting the third week in January.

#### **ORATION CONTEST**

High school students (9th through I 2nd grades) interested in the American Revolution can participate in the Joseph S. Rumbaugh Historical Oration Contest. The contest is open to all students attending public, parochial, private schools, or home school students in that same grade range. The preliminary rounds of the contest begin at the local level and students may potentially advance to the state or national levels where scholarships and cash prizes are awarded. Each student's five-to-six-minute speech (and accompanying manuscript) will be judged based upon its composition. delivery, significance, and historical accuracy and relevance. Interested applicants should reach out to their local SAR chapter for further details.

INTRODUCTION-The information provided below can be found at the National Society Sons of the American Revolution website www.sar.org/education/ and has been slightly modified to specifically address applicants submitting their materials to the Missouri Society SAR. Poster, Brochure, Oration, Knight Essay and History Teacher Competitions at the Chapter level are held prior to December 31. Competitions at the State level will be held at the quarterly Missouri Society Meeting the third week in January. Themes for the Poster and Brochure Contests are determined by the Chairman of each committee and conveyed to Chapter presidents prior to the beginning of the school year, usually in July.

#### POSTER CONTEST

The Americanism Elementary School Poster Contest is open to all 3rd, 4th, and 5th grade students interested in the American Revolution. The contest is open to public or parochial school students, those that are home schooled, as well as those in Scouting, or Children of the American Revolution member students in that same grade range.

Young artists with an enthusiasm toward art, a love of American history, or a passion in creative expression can submit their posters to their local SAR chapter for competition. While the Americanism Poster Contest begins at the local level, students` masterpieces may eventually be judged and monetarily awarded at the national level in June at the annual SAR Congress. Participants from other organizations must be of equivalent age for 3rd, 4th, or 5th grades, whichever year that American History is taught in the specific school district. If American History is taught in lower grades at selected schools, an entry may be accepted for the competition at the discretion of the SAR Americanism Committee. All entries will be judged on an equal basis regardless of point of origin. The

local application deadline is December 31. The theme for the Poster Contest rotates annually based upon whether the school year ends in an even or odd number. For academic years ending in even numbers, the theme shall be "Revolutionary War Events." For academic years ending in odd numbers, the theme shall be "Revolutionary War Person or Persons".

#### **BROCHURE CONTEST**

The purpose of the Brochure Contest is to create a tri-fold brochure out of a typical 8 I/2" x 11 " piece of paper. The brochure must conform to the contest theme which is one the five foundational documents of the United States. The brochure will be judged on: Content, Creativity and Correctness. The judging criteria rates highest personally drawn artwork and text authored by the student as opposed to cut and paste from books, magazines, and the internet. The use of software tools by the student for creating the brochure, and even the artwork, is permissible. The SAR Brochure Contest is open to Middle School students including private, church based and home-schooled students in the 6th, 7th, 8th, or 9th grades, depending upon which year the American Revolution is taught in their educational system. The contest is also open to members

of scouting and the C.A.R. (Children of the American Revolution) who are in the same grades, only when their school system is not participating in the contest. In the case where the local school system, or its equivalent, is participating, the young person needs to enter the contest through the school, and not through a different entity. If the American Revolution period of American History is technically not specifically covered during these middle school grades curriculum, an entity will still be accepted for the competition by SAR. A student can only enter once during these middle school grades. One Brochure per student-not as a group entry. Applicants are judged on how well they understand, develop. and present the specific foundational document of the brochure's theme. Brochures will be judged at the National level focusing on the following three categories: Content, Creativity, & Correctness. Authorship and Use of Technology: the judging criteria rates highest personally drawn art work and authored text by the student as opposed to cut and paste from books, magazines and off the Internet. Though use of material from books, magazines and the Internet does not disqualify an entry, it is just valued less during judging. The use of software tools by the student for creating the brochure. and even the artwork, is permissible. The SAR Brochure Contest theme is the same every year - it does not change from year to year. The six (6) Foundational Documents of the United States that serve as themes for the brochure are: Articles of Confederation, Declaration of Independence, U.S. Constitution, Bill of Rights, Federalist Papers and Articles of Association of 1774.

#### **AMERICAN HISTORY TEACHER AWARD**

All American history teachers, whose approved curriculum teaches students about the American Revolution era from 1750 to 1800, are invited to apply for the Dr. Tom & Betty Lawrence American History Teacher Award. The award is open to all teachers at the elementary, middle school or high school levels at a recognized public, private, or

parochial institution. While the preliminary rounds of the award program begin at the local chapter level, teachers may eventually advance to the state and national levels. The American History Teacher Award recognizes educators who distinguish themselves in teaching the history of the American Revolution. Teacher candidates interested in entering the local SAR Chapter contest must complete the required application and submit a written essay of not less than 1000 words discussing the importance of teaching the American Revolution era. The essay may also describe any extraordinary teaching techniques or innovative projects utilized by the teacher to teach the American Revolution. The contest is aimed at identifying a teacher who is still actively teaching, has taught for at least three years, and who is in the early or middle stages of his or her career, therefore having at least 15 years of productive classroom teaching remaining. The program features a contest at each of the three educational levels so there will be a winner for the elementary school level, the middle school level, and the high school level. An SAR Chapter may submit a contestant to the state from each school level and the state may hold a contest and select a winner from each school level to submit for the national awards. A state may submit a state winner for each level, or from only one or two educational levels. The national winner from each school level will receive potential benefits worth up to \$5.000.00 per winner. The benefits to each winner are as follows: attendance at a teacher workshop or seminar on the American Revolution and up to \$3,000.00 to pay for tuition and travel expenses to attend one of the following teacher seminars: The Freedoms Foundation Seminar, the Teacher Graduate Workshop at Valley Forge, Pennsylvania, the Colonial Williamsburg Summer Teacher Workshop in Williamsburg, Virginia, the Jefferson Symposium at the University of Virginia in Charlottesville, Virginia, or the SAR Annual Conference on the American Revolution. Other seminars may be attended provided the SAR provides prior

approval in writing. The tuition for the seminar will be considered a scholarship and will be paid directly to the seminar. Reasonable travel expenses related to attendance at a seminar will be incurred by the winner and submitted to the SAR for reimbursement. Winners are encouraged to discuss travel plans with the SAR prior to incurring expenses. Reasonable travel expenses may include airfare or mileage in the case of a winner driving a personal vehicle, and room and board where it is not provided by the seminar. Because the educational benefit is \$3,000.00 it is possible that a winner may attend more than one seminar but the total scholarship for tuition, and reimbursement for expenses may not exceed that amount.

#### KNIGHT ESSAY CONTEST

High school students (9th through 12th grades) interested in the American Revolution can participate in the George S. & Stella M. Knight Essay Contest. The contest is open to all US Citizen and Legal Resident students attending home schools, public, parochial, or private high schools in that same grade range. The National Association of Secondary School Principals has placed this program on the 2017-18 NASSP List of Approved Contests, Programs, and Activities for Students. To participate, students must submit an original 800-to 1,200-word essay based on an event, person, philosophy or ideal associated with the American Revolution, Declaration of Independence, or the framing of the United States Constitution. Each student's essay will be judged based upon its historical accuracy, clarity, organization, grammar and spelling, and documentation. The contest is conducted in three phases: the local chapter, state-level society, and national phases. The contest must be entered through an SAR chapter near the student's residence. In some cases, the contest may be entered at the state level (if the state society does not have chapters or the chapters are not participating) and a

contact-at-large should be used to find out more contest details. Only one entry per student is permitted per contest year.

All Public Service awards are to be reported by each chapter to the MOSSAR Public Service Chairman, currently Dale Schmidt, and to the National Chairman, currently Wayne Brown.

# Processing Paperwork and Payments for new members, annual membership renewal, transfers, reinstatements, supplementals, and Compatriot deaths

Chapters MUST be corresponding with the Missouri Society. SAR rather than NSSAR.

Please observe the following for applications.

Brief Overview of who does what: MOSSAR Genealogist verifies the member ancestry, MOSSAR Registrar updates national and state member data. MOSSAR Treasurer processes state payments, MOSSAR Secretary assigns state numbers post NSSAR approval, forwards record copy and membership certificate to chapter president, and provides record copies to Genealogist, Registrar and Treasurer.

Workflow specifies for processing member paperwork and payments are as follows.

New Member application: The MOSSAR Genealogist is tasked with submitting these applications to the NSSAR. This submission requires that the check be attached.

New Member Completed SAR Application and NSSAR dues check should be sent to the MOSSAR Genealogist. • NSSAR Application fee is \$80 and Annual Dues of \$35 for a total check in the amount of \$115.00 payable to NSSAR sent to the MOSSAR Genealogist. • MOSSAR Dues: A separate check in the amount of \$34.00 payable to MOSSAR sent to the MOSSAR Genealogist, who will forward it to the MOSSAR Treasurer, which is \$16 for dues and \$18 application fee. Chapter dues are collected and submitted to the Chapter Treasurer. Note: Amounts may differ for Junior Members and family memberships.

Supplemental • Completed Supplemental SAR Application should be sent to the MOSSAR Genealogist. • NSSAR: Check in the amount of \$60 payable to NSSAR, and a separate check for \$15.00 payable to MOSSAR are sent to the MOSSAR Genealogist. Note: Amount will differ for Family Plan.

Annual Renewal of Membership • MOSSAR Dues: Check in the amount of \$16.00 payable to MOSSAR sent to the MOSSAR Treasurer, and check in the amount of \$35.00 payable to NSSAR sent to MOSSAR Treasurer, who will forward to the NSSAR Treasurer. • Members should NOT pay NSSAR directly.

The MOSSAR Registrar is tasked with submitting Transfer, Reinstatement and Death forms to the NSSAR whereas the MOSSAR Treasurer receives the NSSAR and MOSSAR dues check. (Chapters receive their own dues.) Transfer Member -In • The member in good standing should submit a Form 0919 to his demitting state society. The demitting state society should complete their section and forward to the MOSSAR Registrar. • The MOSSAR Registrar should complete the receiving society section and

forward to NSSAR. • The member in good standing that is transferring into MOSSAR should submit a check for annual dues in the amount of \$16.00 payable to MOSSAR and sent to the MOSSAR Treasurer. • The member in good standing must submit a copy of his SAR Record Copy to the MOSSAR Registrar or remit an additional \$10.00 to cover the cost of MOSSAR obtaining a copy of the Record Copy from NSSAR. Transfer Member -Out • The member in good standing should submit a Form 0919 to the MOSSAR Registrar (his demitting state society). MOSSAR will complete the demitting section and forward to the receiving state society. Transfer Member -Within MOSSAR • Evidence must be provided to the MOSSAR Registrar that a member wants to change from one chapter within MOSSAR to another chapter within MOSSAR. (Transfer in writing either paper or email to Registrar) • The MOSSAR Registrar shall notify the demitting chapter and the receiving chapter when the transfer is completed along with the MOSSAR Secretary. • The MOSSAR Registrar will ensure the NSSAR Membership Data System is revised to reflect the chapter change along with updating the MOSSAR chapter roster. Reinstatement of Member • An SAR Member who has let his membership terminate and desires to reinstate his membership must complete an NSSAR Application for Reinstatement-Transfer of Membership, Form 0918, and submit to the MOSSAR Registrar. • MOSSAR Annual Dues at \$16.00 and Reinstatement Fee at \$5.00 for a total check in the amount of \$21.00 payable to MOSSAR sent to the MOSSAR Treasurer. • NSSAR Dues: Check in the amount of \$ 35.00 payable to NSSAR sent to the MOSSAR Treasurer. • The MOSSAR Registrar will sign the Application form along with updating the data systems and forward to the MOSSAR Treasurer to be sent along with dues to the NSSAR. Note: If the SAR Member is wanting to be reinstated and was a member of another state society, the Application form also serves as a transfer form.

Compatriot Death Report • Compatriot deaths should be reported to the MOSSAR Registrar using a copy of NSSAR Form DR-2019. • MOSSAR will report the compatriot death to NSSAR.

#### **Preface**

The purpose of this guide is to provide a quick reference for the proper description and requirements of awards and medals that can be presented to qualifying members and individuals by both the State Society and the Local Chapters.

The guide provides the *Rules of Precedence* which describes the proper display of all medals and how they are arranged and worn.

The guide is separated into three categories; STATE AWARDS, CHAPTER AWARDS, and medals and awards that <u>BOTH</u> the STATE and LOCAL CHAPTERS can present.

The following information is taken directly from the official SAR Handbook which includes the complete description of the medal and the qualifications that an individual must meet for recognition. The guide also details the possible authorization of subsequent presentations of Oak Leaf Clusters for previously presented medals.

This document does *not* contain any National Awards only those for individuals at the State and Local Chapter levels.

It will be the responsibility of the State Medals and Awards Chairman to procure and prepare the awards for presentation at the states expense after approval of the State President. It will be up to each local chapter to determine how procurement and preparation of awards is to be made at that level.

\*This is a living document and may be updated periodically subject to NSSAR authority.

MOSSAR Medals and Awards

#### **Authority**

#### MEDALS AND AWARDS

For the purposes of this Handbook, SAR medals and insignia include medals, badges, emblems, ribbons, rosettes, sashes, pins and stars. SAR awards include all certificates, plaques, cups and flag streamers.

The awarding of medals and awards should always be given very careful and serious deliberation to determine that the proposed recipient is qualified, deserving, and the occasion for presentation is appropriate. The presentation of medals and awards should not be treated lightly by the National Society, district, state society or a chapter, and should always be given judicious thought to assure that the presentation is in keeping with NSSAR principles. It is essential that the integrity of NSSAR medals and awards be maintained.

The recipient should be made aware that the medal or award is being presented by the approving authority on behalf of the National Society of the Sons of the American Revolution.

They also should realize that they have been honored by the National Society and should wear their medals with pride and in the correct manner. Medals and awards presentations are discussed further in this volume.

The National Society retains the authority to present all of the awards and medals listed in this volume except for those medals or awards specifically reserved to a State Society or Chapter.

#### **Submission of Nominations for Medals and Awards**

#### **Awarding Medals**

The Executive Director, unless otherwise stated in the description for the award, must receive any nomination for an award of a medal for presentation at an Annual Congress, not later than 30 days prior to the date of the Annual Congress. The Executive Director will forward any

nomination received to the respective Committee Chairman for committee consideration.

#### Awarding Certificates

Any nomination for a certificate and any supporting data to be used in making an award of a certificate for presentation at an Annual Congress, unless otherwise stated in the description for the certificate or award, must be received by the Executive Director, not later than 30 days prior to the date of the Annual Congress. The Executive Director will forward any nomination received or supporting data received to the respective Committee Chairman for committee consideration.

#### **Ordering and Presenting Medals and Awards**

1. All awards and medals are presented in the name of the National Society, SAR; the presentation should be made publicly with appropriate ceremony befitting the dignity and honor of the

occasion.

- 2. Medals and awards should be presented in person to the recipient, except under such extenuating circumstances as illness of the recipient, in which case a representative may accept it. Certain medals require special arrangements at NSSAR level for posthumous or representational acceptance. These cases are outlined under the individual medal descriptions. A medal or award should not be mailed to a recipient.
- 3. No medal or award should be ordered or presented by a member without approval of his chapter or state society with exception of the War Service Medal, Military Service Medal, SAR Charter Centennial Medal, gold palm leaves or oak leaf clusters.
- 4. It is recommended that each state society centralize the purchasing of medals and awards through its secretary or treasurer.
- 5. When a medal is presented more than once, it is at the discretion of the presenter whether the medal should be presented or just the oak leaf cluster. In either event, the certificate should accompany the presentation.
- 6. Miniature medals and oak leaf clusters may be purchased and presented with full size medals at the discretion of the presenter.
- 7. All medals and insignia are available from SAR Headquarters. Current prices are published on the SAR Merchandise section of the NSSAR website. Full payment is required at the time of ordering.
- 8. The cost of medals and awards, as well as the cost of engraving or engrossing, must be borne by the organization (national, state or chapter) making the presentation.

#### Care of Insignia and Medals

Members should be aware that the bylaws of a corporation form the rules of a corporation. Under the bylaws, members agree that the SAR Badge "will be worn or used in accordance with the regulations of the Society." They further agree, on behalf of themselves, their heirs, executors, administrators, also any and all persons asserting any claims through them, to give the SAR a right of first purchase of their SAR Badge or other regalia. Members should therefore be aware that by becoming SAR members they have given the SAR legal authority to prevent improper transfers of SAR insignia.

Members are requested to guard against insignia being available in resale shops, antique shops, and so forth. Every effort should be made to redeem them to the Society.

#### Additional Awards of the Same Medal (Oak Leaf Clusters)

A member may be awarded several National Society medals more than once: Meritorious Service Medal, Roger Sherman Medal, Medal for Heroism, Bronze Good Citizenship Medal, Liberty Medal, C.A.R.-SAR Medals of Appreciation, Samuel Adams Congress Planning Medal, Service to Veterans Medal, and the Florence Kendall Award.

Each medal previously listed has its own criteria. Please refer to the specific medal in the Handbook for the number of oak leaf clusters and/or multiple awards permitted. Also, any multiple awards of state society medals should use the oak leaf cluster system.

The color of the oak leaf cluster and the number of clusters indicates the number of times the wearer has received the medal. A bronze oak leaf cluster is worn for each additional medal up to five. If more than five medals are presented, a silver oak leaf cluster should be worn in lieu of each five bronze oak leaf clusters, and a gold oak leaf cluster in lieu of two silver oak leaf clusters. Oak leaf clusters are available in one size only, and may be worn on either full size or miniature medals.

The oak leaf clusters are worn in the middle of the ribbon, horizontally,

with the large part of the leaf slightly elevated and pointing to the wearer's left or "sinister" side.

Each additional medal must have been presented based on the same criteria as the first presentation; but each additional presentation must reward separate and distinct acts.

In the event a member has received additional medals of the same kind, he should make use of the oak leaf cluster system. He should not wear two or more medals of the same kind at the same time.

#### **PRECEDENCE**

#### **General Comments on Precedence**

The position of honor is on the wearer's right and on the top. The general rule of precedence when SAR medals are worn with other medals follows, but an individual should refer to the relevant publication for specific precedence for his military branch, governmental department, or the specific requirements of the individual award. Miniature medals are not worn without their ribbons as the ribbon forms an integral part of the decoration.

- 1. **Federal Decorations**: Consult the most current relevant publication for medal precedence for proper sequence.
- 2. **Federal Campaign Medals**: Consult the most current relevant publication for medal precedence for proper sequence.

- 3. **Foreign Military and Civilian Decorations**: For foreign campaign decorations, consult the most current relevant publication for medal precedence for proper sequence. For foreign civilian decorations, consult the relevant publication or the specific requirements of the decoration, honor or award. If no relative order of precedence is available, foreign civilian decorations should be ordered from right to left by the date on which they were awarded.
- 4. U.S. State Decorations, U.S. State Campaign Medals and U.S. State Organizational and Long Service Medals.
- 5. SAR Insignia and Insignia of Other Hereditary, Patriotic and Veterans Societies: Insignia are worn in chronological order of precedence according to the year of establishment of such organization. Medals awarded for service to a particular organization (such as the medals described herein) should be placed immediately following the insignia of the respective organization in the order of precedence established by that organization (for SAR Medals, the order of precedence is specified in the following pages).

# **Detail of SAR Medal Precedence and Summary Table of Medals and Awards**

NSSAR medals are worn in the following order of precedence from the wearer's right to left:

#### MEDAL

- 1. SAR Badge [unless on neck ribbon]

# MEDALS AWARDED BY A STATE SOCIETY TO COMPATRIOTS FOR SERVICE TO THE SAR

#### **Patriot Medal**

Precedence: 9 Year Authorized: 1964 Presented By: State Society

Approved By: State Society

Description: The medal has a silver finish and bears the portrait of Compatriot General of the Army Douglas MacArthur on the obverse within the inscription, "The National Society of the Sons of the American

Revolution." The reverse is inscribed "Awarded to for Patriotic Service by the Society SAR, 20\_\_. The medal is suspended from a chest ribbon of royal blue color. Compatriot MacArthur selected the design for the medal just prior to his death. He received the first medal, presented posthumously at his tomb in Norfolk, Virginia, on October 19, 1964, where it is on permanent display. The Patriot Medal is available in full and miniature sizes. *The medal is also available from SAR Merchandise in Sterling Silver as a Special Order item*.

Summary: The Patriot Medal is the highest award presented to a Compatriot by a State Society and recognizes long, faithful, outstanding, and distinguished service at the state and/or chapter level. The Patriot Medal is awarded only by a State Society and may be presented only to an individual. Service at the national level is not considered in making the award. It is desirable that it be presented at the annual meeting of the State Society. A representative cannot accept the Patriot Medal. All requirements should be thoroughly reviewed before requesting this medal.

Limitations on Presentation: The Patriot Medal may be awarded annually by any state society. State societies with fewer than 500 members may present no more than one medal each calendar year. State societies with 500 to 1000 members may present two medals each calendar year. State societies with over 1000 members may present one medal for each 500 members. The cutoff date for determining the number of medals that a society may award in the following year is 31 December of the prior calendar year.

Subsequent Presentation NOT Authorized: A Compatriot may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

## **State Medal of Distinguished Service**

Precedence: 10 Year Authorized: 1998 Presented By: State Society Approved By: Society President

Description: The State Medal of Distinguished Service ("SMDS") is diamond shaped with a blue SAR insignia surmounted on a white enamel background and trimmed in silver hanging from a drape of solid maroon ribbon. A miniature medal is available.

Authorized Presentation: The incumbent State President may present one medal during his term (or each year of his term if elected to a multiyear term) at the Society's Annual Meeting to a Compatriot in recognition for that Compatriot's conspicuous service to the State Society President during his administration. The SMDS is awarded by a State Society President at his discretion; no other approval is required.

Subsequent Presentation NOT Authorized: A Compatriot may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

#### **State Meritorious Service Medal**

Precedence: 12 Year Authorized: 1980 Presented By: State Society Approved By: State Society

*Description*: The medal is the same medal used for the National Meritorious Service Medal.

Summary: The State Meritorious Service Medal may be awarded to SAR members who have rendered long, faithful and meritorious service to their state society. The meritorious service rendered should be stated in the citation.

Subsequent Presentation NOT Authorized: A Compatriot may receive this medal only once from a state society.

Special Note Regarding Oak Leaf Clusters: Although a member may receive the award multiple times from the National Society, and once from each of a district, a state society or a chapter, only one Meritorious

Service Medal is worn. Once a member has received the Meritorious Service Medal, subsequent awards by additional conferring authorities are represented by oak leaf clusters (regardless of the conferring authority).

#### Silver Roger Sherman Medal

Precedence: 14 Year Authorized: 2013 Presented By: State Society

Approved By: State Society

Description: The medal is antique silver in color and bears on the obverse a portrait of Roger Sherman, with the inscription "Roger Sherman Medal." The reverse of the medal is inscribed "In Appreciation for Service to the SAR." It is suspended from a chest ribbon of blue, white and red.

Summary: The Silver Roger Sherman Medal may be awarded to a compatriot in recognition of, and in appreciation of, outstanding services rendered to a State Society. The medal is presented to a compatriot for significant service which lacks the requirements for the Meritorious Service Medal. It should be awarded in place of the Bronze and Silver Good Citizenship Medals, which cannot be awarded for service to the SAR. The recipient must have served as an active officer for a minimum of two years, as an active committee chairman for three years, or as an active member of a committee for four years.

This Medal is named after Roger Sherman (1721-1793), who was a founding father, and the only person to sign all four Congressional papers of the United States: the Continental Association, the Declaration of Independence, the Articles of Confederation and the Constitution.

Subsequent Presentation Authorized: A Compatriot may receive this medal multiple times. A bronze oak leaf cluster may be awarded for an additional two years of active service as an officer, chairman or committeeman. The service is counted cumulatively rather than consecutively, and may not be added concurrently for multiple offices, committee chairmanships, or committee memberships. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

#### Silver Good Citizenship Medal

Precedence: 15 Year Authorized: 1939 Presented By: National Society or State Society. A Chapter may present this medal only if

approved by its state society. *Approved By*: NSSAR Executive Committee or State Society (based on presenting authority)

*Description*: The medal is silver in color. A certificate suitable for engrossing is available. A miniature medal is also available.

Summary: The Silver Good Citizenship Medal recognizes outstanding and unusual patriotic achievement and service that is of a more local degree (state or regional level) than required for the Gold Good Citizenship Medal. The medal is presented to persons of prominence in the areas of government (including military service), religion, education, business and other professions, and other fields of endeavor. Since it recognizes extensive service, a biographical sketch of the candidate should accompany the request for a medal. There is no requirement that persons must be awarded a Bronze Good Citizenship Medal before they may be awarded a Silver Good Citizenship Medal.

*Non-member Service Requirements*: In the case of a non-member, the National Society or a state society determines the qualifications.

Compatriot Service Requirements: In the case of a Compatriot, in order to have uniform criteria, the requirement has been established that the member shall have served in six leadership capacities in any of the following local organizations: Church, School, Scouting, Fraternal, Business Associations, Government, Patriotic, Military, Veterans, Conservation, Hereditary, Genealogical, Historical or organized Sports (Little League, etc.).

*SAR Service Restriction*: The Silver Good Citizenship Medal should **not** be used to recognize service to the SAR, which is recognized by the Minuteman Award, the National Medal of Distinguished Service, the State Medal of Distinguished Service, Patriot Medal, the Chapter Medal

of Distinguished Service, Meritorious Service Medal, and the Roger Sherman Medal.

Subsequent Presentation NOT Authorized: An individual (including Compatriots) may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

#### **Missouri Society Gold Medal**

*Description:* The medal is gold and depicts the Battle of Fort San Carlos in Missouri with a red and yellow drape.

Summary; This medal is ceremonial and presented to SAR members in recognition of long service to the Missouri Society. It also can be presented to distinguished guests, dignitaries or outstanding citizens. The medal and certificate is presented in a frame for hanging.

#### **Missouri Glass Trophy**

This trophy is given to individuals in recognition of their long and faithful service to the Missouri State Society. It is also presented to the winners of the MOSSAR Teacher(s) of the Year Award winner.

MEDALS AWARDED BY THE NATIONAL SOCIETY, A STATE SOCIETY OR A CHAPTER TO YOUTH FOR PARTICIPATION IN YOUTH AWARD PROGRAMS

#### Silver ROTC Medal

Precedence: 28 Year Authorized: 1933 Presented By: National Society, State Society or Chapter Approved By: NSSAR Executive Committee, State Society or Chapter (based on presenting authority).

*Description*: The medal is silver in color, suspended from a ribbon of the SAR colors. The obverse depicts a Minuteman holding a rifle, with a plow and the Liberty Bell in the background, and is inscribed "ROTC."

The reverse is inscribed "Awarded for Leadership, Soldierly Bearing and Excellence to \_\_\_\_\_\_." A ribbon bar in the SAR colors with a silver sword device is included and a certificate is available. Miniature is not available.

Summary: The National Society, a state society or a chapter, may present this award **only** to students enrolled in a college or university ROTC program.

Qualifications: The medal endeavors to foster the principle of "citizen-soldier" exemplified by the Minutemen and recipients should be selected by the commanding officer of the ROTC unit based on their military bearing, leadership potential, attitude, scholastic achievements and general excellence.

Commanding officers should be given full latitude in selecting an outstanding ROTC cadet.

Limitations on Presentation: One medal will normally be awarded each year in ROTC units with fewer than 500 cadets or midshipmen. For larger units, one medal may be presented for each 500 students enrolled in the unit. Moreover, where a school has more than one ROTC unit, each unit is counted separately. It is desirable to have the medal on display with its ribbon bar in a trophy case at each school where it is presented. This will serve as an incentive to the students and publicize the SAR ROTC program as well.

Subsequent Presentation NOT Authorized: A cadet may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

**Silver Children of the American Revolution – Sons of the American Revolution Medal of Appreciation** *Precedence*: 22 *Year Authorized*: 1999 *Presented By*: National Society or State Society *Approved By*: NSSAR C.A.R. Liaison Committee or State Society

Description: The Silver C.A.R.-SAR Medals of Appreciation is silver in color and bears a relief of the C.A.R. National Emblem on the obverse and are circumscribed with the legend "SAR C.A.R. Medal of Appreciation." It is suspended from a chest ribbon of the SAR colors. A certificate accompanies the medal. A miniature medal is available.

Summary: The National Society or a State Society may present the Silver C.A.R.-SAR Medal of Appreciation to a member of the C.A.R. or SAR in good standing in recognition of and in appreciation for outstanding services rendered to a State C.A.R. Society. The award may also recognize outstanding C.A.R. Senior leaders of a State Society or SAR members who have significantly supported or served a State C.A.R. Society.

Subsequent Presentation Authorized: A Compatriot may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

# MEDALS AWARDED BY THE NATIONAL SOCIETY, A DISTRICT, A STATE SOCIETY OR A CHAPTER TO A LADY FOR SERVICE TO THE SAR

#### The Molly Pitcher Medal

Precedence: 45 Year Authorized: 2012 Presented By: District Vice President General, State President, or by the District or State Color

Guard Commander (as appropriate). Under special circumstances, the President

General or the National Color Guard Commander may present this award. *Approved By*: State or District Color Guard Commander and National Color Guard Commander

Description: The Medal is silver in color and depicts a likeness of Molly

Pitcher. It is available only in miniature.

Summary: Many women who are the wives, daughters, sisters, girlfriends, and other female relatives and companions of SAR Color Guardsmen routinely and with great dedication support their SAR Color Guardsman and the SAR Color Guard. The Molly Pitcher Medal may be awarded to women who have supported the SAR Color Guard at the State, District and National Levels.

Special Application Required: Women who believe they qualify for the Molly Pitcher Medal must complete the appropriate form, setting forth their qualifications. The form may also be completed by their husband or other male companion. This form is available on the SAR website and must be submitted to the State or District Color Guard Commander for review and recommendation, and then to the National Color Guard Commander for final authorization to award the Molly Pitcher Medal.

Requirement of Silver Color Guard Medal: Before a woman may be awarded the Molly Pitcher Medal, her husband or other male companion must have been awarded the SAR Silver Color Guard Medal.

Qualifications: To earn the Molly Pitcher Medal, a woman must be present at, and support, the SAR Color Guard at qualifying SAR Color Guard events. The same events that count toward earning the SAR Silver Color Guard Medal for SAR Color Guardsmen shall also count toward earning the Molly Pitcher Medal. In addition, participation in, and support of, State events, such as a State Society Annual Meeting or a State Society Board of Managers/Governors Meeting, shall also count toward earning the Molly Pitcher Medal.

#### A. Point System

1. To earn the Molly Pitcher Medal, a woman must accrue at least three hundred (300) points by participating in qualifying State, District and National Color Guard events for at least three (3) years.

She may take longer to accrue the requisite 300 points, but even if she accrues 300 points or more within three years, she may not be awarded the Molly Pitcher Medal for less than three years of service. The requisite three years do not need to be continuous; a year shall be any period of twelve consecutive months. A woman supporting an SAR Color Guardsman shall earn ten (10) points for her presence and support at each qualifying State Color Guard event, twenty (20) points for her presence and support at each qualifying District and National Color Guard event.

- 2. For Color Guardsmen whose State societies employ the point system, they may also earn points based on mileage, whether such miles are traveled by driving or by flying. (*Please see the NSSAR Color Guard Manual for updated numbers*).
- Up to 100 miles, 0 points;
- From 101 to 200 miles, 5 points;
- From 201 to 999 miles, 10 points;
- From 1,000 miles and over, 20 points.

#### B. Events System

1. To earn the Molly Pitcher Medal, a woman must participate in at least three (3) State, District, or National events in each of three (3) years. The requisite three years do not need to be continuous; a year shall be any period of twelve (12) consecutive months.

Support Defined: A woman may be said to 'support' the SAR Color Guard by participating in SAR Color Guard events wearing Revolutionary-era attire, or by bringing refreshments for participating SAR Color Guardsmen, or by providing some other tangible support for her SAR Color Guardsman. However, merely attending an SAR Color Guard event shall not be deemed as 'support' for the purposes of earning the Molly Pitcher Medal.

Subsequent Presentation NOT Authorized: A lady may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

Retroactive Effectiveness: Women who were actively supporting an SAR Color Guardsman and the SAR Color Guard at the time this Medal was authorized (28 September 2012 by the NSSAR Executive Committee) may count any qualifying SAR Color Guard event in which they participated during the two (2) year period prior to the authorization date toward earning the Molly Pitcher Medal.

#### SAR Daughters of Liberty Medal (YOHE Woman of the Year)

Precedence: 8 Year Authorized: 1992 Presented By: National Society, District or State Society. A Chapter may present this Medal

only if approved by the State Society. *Approved By*: NSSAR Executive Committee, District Vice President General or State Society (depending on presenting authority).

Description: The medal is gold in color, and depicts Sybil Ludington riding a galloping horse, commemorating her heroic ride of April 26, 1777 to warn of the approach of British forces and symbolizing the contribution of the many women who aided in the struggle for American independence. The medal is suspended from a drape of blue, yellow and blue bands of equal width. The medal is available in miniature. A certificate to be engrossed and presented with the medal accompanies the medal.

Summary: The Daughters of Liberty Medal may be presented to a lady recommended by any officer of a chapter, state or National Society, SAR in appreciation for her unselfish devotion, tireless efforts and assistance to the SAR, and who has dedicated her time, energy, ability and/or finances to the organization in support and furtherance of the stated objectives of

the SAR. This is the highest lady's medal and consideration in awarding this medal should be given only after the SAR Medal of Appreciation or the Martha Washington Medal has been presented.

Subsequent Presentation Authorized: A lady may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy

*Description*: The Chapter Medal of Distinguished Service ("CMDS") is diamond shaped with a blue SAR insignia surmounted on a white enamel background and trimmed in bronze hanging from a drape of solid maroon ribbon. A miniature medal is available. The CMDS is the highest medal that can be awarded by a Chapter President.

Authorized Presentation: The incumbent Chapter President may present

one medal during his term (or each year of his term if elected to a multiyear term) at the Chapter's Annual Meeting, to a Compatriot in recognition for that Compatriot's conspicuous service to the Chapter during the president's administration. The Chapter President presents this Medal at his discretion; no other approval is required.

Subsequent Presentation NOT Authorized: A Compatriot may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

Retroactive Effectiveness: Former chapter presidents who have not made a presentation of this award would be eligible to present the medal to a compatriot upon the presentation of a letter to the incumbent Chapter President describing the assistance provided by the member.

## **Chapter Meritorious Service Medal**

Precedence: 12 Year Authorized: 1980 Presented By: Chapter Approved

By: Chapter

Description: The medal is the same medal used for the National Meritorious Service Medal.

Summary: The Chapter Meritorious Service Medal may be awarded to SAR members who have rendered long, faithful and meritorious service to their chapter. The meritorious service rendered should be stated in the citation.

Subsequent Presentation NOT Authorized: A Compatriot may receive this medal only once from a chapter.

Special Note Regarding Oak Leaf Clusters: Although a member may receive the award multiple times from the National Society, and once

from each of a district, a state society or a chapter, only one Meritorious
Service Medal is worn. Once a member has received the Meritorious
Service

Medal, subsequent awards by additional conferring authorities are represented by oak leaf clusters (regardless of the conferring authority).

#### **Bronze Roger Sherman Medal**

Precedence: 26 Year Authorized: 2013 Presented By: Chapter Approved By: Chapter

Description: The medal is antique bronze in color and bears on the obverse a portrait of Roger Sherman, with the inscription "Roger Sherman Medal." The reverse of the medal is inscribed "In Appreciation for Service to the SAR." It is suspended from a chest ribbon of blue, white and red.

Summary: The Bronze Roger Sherman Medal may be awarded to a compatriot in recognition of, and in appreciation of, outstanding services rendered to a Chapter. The medal is presented to a compatriot for significant service which lacks the requirements for the Meritorious Service Medal. It should be awarded in place of the Bronze and Silver Good Citizenship Medals, which cannot be awarded for service to the SAR. The recipient must have served as an active officer for a minimum of two years, as an active committee chairman for three years, or as an active member of a committee for four years.

This Medal is named after Roger Sherman (1721-1793), who was a founding father, and the only person to sign all four Congressional papers of the United States: the Continental Association, the Declaration of Independence, the Articles of Confederation and the Constitution.

Subsequent Presentation Authorized: A Compatriot may receive this medal multiple times. A bronze oak leaf cluster may be awarded for an additional two years of active service as an officer, chairman or committeeman. The service is counted cumulatively rather than

#### **Bronze NSSAR Color Guard Medal**

Precedence: 44 Year Authorized: 1998 Presented By: State Society President or Chapter President Approved By: State Awarding Authority (State Color Guard Commander)

Summary: The Bronze Color Guard Medal is for service at the State and/or Chapter levels. Each medal is awarded for at least three years of service at the applicable level. The three years may be broken, not continuous. Award of each medal may be for retroactive service, so that any living compatriot may receive it, even if he cannot march anymore.

Qualifications: Each State Society shall determine for itself whether to employ one of the following systems for earning the Bronze and Silver Color Guard Medals. The first system is based on points; the second system is based on the number of events in which a Guardsman participates.

#### A. Point System

- 1. To earn an SAR Bronze Color Guard Medal, a Color Guardsman must accrue at least three hundred (300) points by participating in uniform at qualifying Chapter and/or State Color Guard events.
- 2. A Color Guardsman shall earn five (5) points for his participation in uniform in each Chapter event. A Chapter event shall be defined as an event in which a Chapter participates, but to which an invitation has not been extended to the State Color Guard. Examples include, but are not limited to: participation at schools, civic clubs, churches and other public organizations, Chapter meetings, flag retirement

ceremonies, local veterans events, local Revolutionary War event celebrations, proclamation ceremonies by local governments, and similar local events. The Chapter President should approve a Chapter event before the event may be counted.

- 3. A Color Guardsman shall earn ten (10) points for his participation in uniform in each State event. A State event is an event in which the State Color Guard has been requested to participate. Examples include, but are not limited to: Revolutionary battle and historic sites celebrations, grave markings, parades, State Society meetings. The State President should approve a State event before the event may be counted.
- 4. A Color Guardsman must keep track of the events in which he has participated, and must prove that he has accrued 300 points to the State President or State Color Guard Commander, or to such other appropriate State authority.
- 5. For Color Guardsmen whose State societies employ the point system, they may also earn points based on mileage, whether such miles are traveled by driving or by flying. (*Please see the NSSAR Color Guard Manual for updated numbers*).
- Up to 100 miles, 0 points;
- From 101 to 200 miles, 5 points;
- From 201 to 999 miles, 10 points;
- From 1,000 miles and over, 20 points.

## B. Events System

1. To earn an SAR Bronze Color Guard Medal, a Color Guardsman must participate in at least 50% of the scheduled Color Guard activities for his

State and/or Chapter in each of three years, which do not need to be continuous. A year shall be any period of twelve consecutive months.

#### **Bronze Good Citizenship Medal**

Precedence: 27 Year Authorized: 1895 Presented By: National Society, State Society or Chapter Approved By: NSSAR Executive Committee, State Society or Chapter (based on presenting authority)

*Description*: The medal is bronze in color. A certificate suitable for engrossing is available. A miniature medal is also available.

Summary: The Bronze Good Citizenship Medal is a multi-purpose award designed to recognize individuals who have whose community (*i.e.*, school, locality or state) achievements are noteworthy. It can be presented to both adults and minors and to Compatriots (subject to below limitation) and non-Compatriots alike. The medal was originally

designed as a medallion, but a ribbon and clasp were added in 1932 to convert it to a medal.

*Non-Compatriot Presentation Suggestions*: The following are some examples for presenting this award:

- 1. *Community Involvement:* An individual who has made an important contribution to the community that is not as significant as those contributions that would qualify for the Silver Good Citizenship Medal.
  - 1. School Involvement: The outstanding high school student in his/her school considering both citizenship and scholarship. The exact criteria is at the discretion of the presenting authority (*i.e.*, it could be presented to a high school senior or junior based on overall scholarship and citizenship; or to a high school student with the highest grades in American history; or a high school student with

the best record in citizenship, etc.)

2. *U.S. Naval Sea Cadet Corps (NSCC):* This medal is authorized for presentation to a cadet in the U.S. Navy Sea Cadet Corps (NSCC) to an Outstanding Cadet as nominated by his/her Commanding Officer. **Eligibility criteria**: The award is presented to a cadet who (1) is in the NSCC Program (not the NLCC Program), (2) is in his or her last, or next to last, year in the NSCC program, (3) has attained the rank of Petty Officer Second Class or above; (4) is in good standing militarily and scholastically at the time of selection and presentation; (5) demonstrates a high degree of merit with respect to leadership qualities, military bearing, and excellence in the performance of duties; (6) has the potential for greater leadership responsibilities; and (7) is recommended by the unit Commanding Officer.

Compatriot Presentation Requirements: A Compatriot may be awarded the Bronze Good Citizenship Medal if either (1) he has served, subject to the restriction described immediately below, in at least four of the leadership capacities covered under the Silver Good Citizenship Medal (see above), or (2) he qualifies by some other outstanding achievement in his community. Subsequent awards must be for different service than the service used for prior awards.

SAR Service Restriction: The Bronze Good Citizenship Medal is not used to recognize service to the SAR. SAR service is only recognized by the Minuteman Award, the National Medal of Distinguished Service, the State Medal of Distinguished Service, Patriot Medal, the Chapter Medal of Distinguished Service, Meritorious Service Medal, the Roger Sherman Medal, and any nationally approved District or State Society service medal.

Subsequent Presentation Authorized: An individual may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

#### **Bronze ROTC Medal**

Precedence: 29 Year Authorized: 1965 Presented By: National Society, State Society or Chapter Approved By: NSSAR Executive Committee, State Society or Chapter (based on conferring authority)

Description: The medal is bronze in color, suspended from a ribbon of the SAR colors. The obverse depicts a Minuteman holding a rifle, with a plow and the Liberty Bell in the background, and is inscribed "ROTC." The reverse is inscribed "Awarded for Leadership, Soldierly Bearing and Excellence to \_\_\_\_\_\_." A ribbon bar in the SAR colors is included and a certificate is available. Miniature is not available.

Summary: The National Society, a state society or a chapter, may present this award **only** to students enrolled in a high school or secondary school JROTC program.

Qualifications: The medal endeavors to foster the principle of "citizen-soldier" exemplified by the Minutemen and recipients should be selected by the commanding officer of the ROTC unit based on their leadership qualities, military bearing and general excellence. Although commanding officers should be given full latitude in making the selection, the following specific criteria must be met:

- 1. The cadet must be currently enrolled in the JROTC Program;
- 2. The cadet should be a third-year cadet in a four-year program or a second-year cadet in a three-year program;
- 3. The cadet must be in the top 10% of his or her JROTC class;
- 4. The cadet must be in the top 25% of his or her overall class; and

5. The cadet may not have received the Bronze ROTC Medal previously from the Sons of the American Revolution.

Limitations on Presentation: One medal will normally be awarded each year in JROTC units with fewer than 500 cadets or midshipmen. For larger units, one medal may be presented for each 500 students enrolled in the unit. Moreover, where a school has more than one JROTC unit, each unit is counted separately. It is desirable to have the medal on display with its ribbon bar in a trophy case at each school where it is presented. This will serve as an incentive to the students and publicize the SAR JROTC program as well.

Special Note Regarding the US Navy Sea Cadet Corps (NSCC): Sea Cadets are no longer eligible to receive the SAR Bronze Medal. The NSCC should be supported by recognizing the Outstanding NSCC Cadet with the Bronze Good Citizenship Medal. A ribbon bar for the Bronze Good Citizenship Medal is available from Merchandise specifically for use for the Sea Cadets.

Subsequent Presentation NOT Authorized: A cadet may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

#### **Eagle Scout Medal**

Precedence: 30 Year Authorized: 1981 Presented By: Chapter Approved By: Chapter Eagle Scout Chairman

Description: The medal is in bronze, with a design identical to the Bronze Good Citizenship Medal, with the exception that the words "Eagle Scout" are inscribed at the bottom of the obverse side. It is not available in miniature.

Summary: A chapter may award this medal annually to the Eagle Scout who is the winner of the chapter's Eagle Scout Scholarship Competition.

Subsequent Presentation Authorized: An Eagle Scout may receive this medal multiple times if he competes in and wins his chapter's scholarship competition in subsequent years. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

**Bronze Children of the American Revolution – Sons of the American Revolution Medal of Appreciation** *Precedence*: 23 *Year Authorized*: 1999 *Presented By*: National Society, State Society or Chapter *Approved By*: NSSAR C.A.R. Liaison Committee, State Society or Chapter

Description: The Bronze C.A.R.-SAR Medals of Appreciation is bronze in color and bears a relief of the C.A.R. National Emblem on the obverse and are circumscribed with the legend "SAR C.A.R. Medal of Appreciation." It is suspended from a chest ribbon of the SAR colors. A certificate accompanies the medal. A miniature medal is available.

Summary: The National Society, a State Society or a local Chapter, may present the Bronze C.A.R- SAR Medal of Appreciation to a member of the C.A.R. or SAR in good standing in recognition of and in appreciation for outstanding services rendered to a local C.A.R. Society. The award may recognize assistance in promoting C.A.R. members that qualify to obtain SAR memberships, C.A.R. members who participate in the State Society Annual Meetings or at the National Congress, C.A.R. members who have otherwise significantly aided SAR programs, or SAR members and C.A.R. Senior Leaders who have supported or served a state or local C.A.R. Society.

Subsequent Presentation Authorized: A Compatriot may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

## Missouri Society Bronze Medal

Description: The medal is bronze and depicts the Battle of Fort San Carlos in Missouri with a red and yellow drape.

Summary; This medal is ceremonial and presented to SAR members in recognition of long service to the Chapter or the Missouri Society. It also can be presented to distinguished guests, dignitaries or outstanding citizens.

# MEDALS AWARDED BY A CHAPTER TO A LADY FOR SERVICE TO THE CHAPTER

## **SAR Daughters of Liberty Medal**

Precedence: 8 Year Authorized: 1992 Presented By: National Society, District or State Society. A Chapter may present this Medal

only if approved by the State Society. Approved By: NSSAR Executive Committee, District Vice President General or State Society (depending on presenting authority).

Description: The medal is gold in color, and depicts Sybil Ludington riding a galloping horse, commemorating her heroic ride of April 26, 1777 to warn of the approach of British forces and symbolizing the contribution of the many women who aided in the struggle for American independence. The medal is suspended from a drape of blue, yellow and blue bands of equal width. The medal is available in miniature. A certificate to be engrossed and presented with the medal accompanies the medal.

Summary: The Daughters of Liberty Medal may be presented to a lady recommended by any officer of a chapter, state or National Society, SAR in appreciation for her unselfish devotion, tireless efforts and assistance to the SAR, and who has dedicated her time, energy, ability and/or finances to the organization in support and furtherance of the stated objectives of

the SAR. This is the highest lady's medal and consideration in awarding this medal should be given only after the SAR Medal of Appreciation or the Martha Washington Medal has been presented.

Subsequent Presentation Authorized: A lady may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy

# The following medals and awards that can be presented by <u>both</u> the State Society and the local Chapter

#### **SAR Life Saving Medal**

Precedence: 17 Year Authorized: 2017 Presented By: National Society, State Society or Chapter Approved By: National Society, State Society or Chapter (based on presenting authority)

*Description*: The medal is gold in color. The obverse depicts a green cross in the center enclosed within a green circle. Within the green circle, the words "Sons of the American Revolution" appear on top and "Life

Saving" appears on the bottom. It is worn from a chest ribbon of red halved with white. The medal is accompanied by a half red, half white enameled bar, suitable for wear on uniform, and a certificate for engrossing. A miniature medal is available.

Summary: The SAR Life Saving Medal is presented to those individuals who have acted to save a human life without necessarily placing their own life or themselves in imminent danger. The medal is intended primarily for acts by civilians not in uniform, however, police officers, fire fighters, emergency medical personal, lifeguards, and SAR Compatriots are not excluded from receiving this award. The medal is not intended to recognize acts that would otherwise qualify for military or another organization's valor medals and, in all cases, the fact that the actions of the rescuer actually saved the life of the victim must be validated by EMS or medical personnel. Lifesaving examples include, but are not limited to, the following:

- 1. Performing the Heimlich maneuver or other first aid to prevent a person from choking;
- 2. Saving a person from drowning by bringing the person to safety;
- 3. Performing cardiopulmonary resuscitation (CPR) or rescue breathing until the person breathes normally; or
- 4. Performing CPR or applying an automated external defibrillator (AED) on an out-of-hospital cardiac arrest before EMS arrival.

The medal is intended to recognize the actions of any person: (1) who was directly responsible for the saving of a human life or (2) who prolonged a human life to the extent that the victim was still alive upon transfer to the care of medical authorities, even though the victim might expire at a later time.

Only one award will be awarded for each incident regardless of the number of victims involved. Nominations will not be considered after a lapse of 24 months of the incident. The medal may also be presented posthumously.

*Publication*: The names of all recipients are published annually. Each awarding chapter and state society is requested to forward a short written description of the background and accomplishments of the recipients, together with dates, places and names. This should be submitted to National Headquarters, ATTN: Public Service and Heroism Committee and should arrive no later than June 1 each year. The report format is available on the SAR web site.

Subsequent Presentation Authorized: A Compatriot may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

#### **Law Enforcement Commendation Medal**

Precedence: 18 Year Authorized: Presented By: National Society, State Society or Chapter Approved By: National Society, State Society or Chapter (based on presenting authority)

Description: The obverse of the medal depicts a police badge design surmounted by a gold eagle with the SAR Badge below. The medal is accompanied by an enameled bar, suitable for wear on uniform, and a certificate for engrossing. A miniature medal is available.

Summary: The Law Enforcement Commendation Medal is presented to those who have served with distinction and devotion in the field of law

enforcement. The medal is intended to recognize exceptional service or accomplishment in the field of law enforcement. Eligibility is not limited to peace officers but extends to the entire range of persons who make and enforce the law to include but not limited to peace officers, attorneys, judges, prosecutors and legislators who have performed an exceptional act or service beyond that normally expected. The medal may be presented posthumously.

*Publication*: The names of all recipients are published annually. Each awarding chapter and state society is requested to forward a short written description of the background and accomplishments of the recipients, together with dates, places and names. This should be submitted to National Headquarters, ATTN: Public Service and Heroism Committee and should arrive no later than June 1 each year. The report format is available on the SAR web site.

Subsequent Presentation NOT Authorized: An individual may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

## **Fire Safety Commendation Medal**

Precedence: 19 Year Authorized: Presented By: National Society, State Society or Chapter Approved By: National Society, State Society or Chapter (based on presenting authority)

*Description*: The obverse of the medal depicts a fireman's badge with a flame in the center. The medal is accompanied by an enameled bar, suitable for wear on uniform, and a certificate for engrossing. A miniature medal is available.

Summary: The Fire Safety Commendation Medal is presented to an individual for accomplishments and/or outstanding contributions in an area of fire safety and service. The award is not limited to firefighters. It

may be presented to recognize a variety of fire safety and service that has evolved into a highly technical and skilled profession with constant study, development and involvement by numerous dedicated citizens with a single goal - protect human life and property by preventing injuries or casualties due to fire and chemicals. The medal may be presented posthumously.

*Publication*: The names of all recipients are published annually. Each awarding chapter and state society is requested to forward a short, written description of the background and accomplishments of the recipients, together with dates, places and names. This should be submitted to National Headquarters, ATTN: Public Service and Heroism Committee and should arrive no later than June 1 each year. The report format is available on the SAR web site.

Subsequent Presentation NOT Authorized: An individual may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

#### **Emergency Medical Services Commendation Medal**

Precedence: 20 Year Authorized: 2005 Presented By: National Society, State Society or Chapter Approved By: National Society, State Society or Chapter (based on presenting authority)

*Description*: The obverse of the medal depicts an EMS badge. The medal is accompanied by an enameled bar, suitable for wear on uniform, and a certificate for engrossing. A miniature medal is available.

Summary: The Emergency Medical Services Commendation Medal is presented to an individual for accomplishments and/or outstanding contribution in an area of emergency medical services. The award is

intended for paramedics and certified Emergency Medical Technicians and others in the

emergencymedicalfieldwhohaveperformedanactorservicebeyondthatnorm allyexpected. The medal may be presented posthumously.

*Publication*: The names of all recipients are published annually. Each awarding chapter and state society is requested to forward a short written description of the background and accomplishments of the recipients, together with dates, places and names. This should be submitted to National Headquarters, ATTN: Public Service and Heroism Committee and should arrive no later than June 1 each year. The report format is available on the SAR web site.

Subsequent Presentation NOT Authorized: An individual may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.

#### Medal for Heroism

Precedence: 5 Year Authorized: Presented By: National Society, State Society or Chapter Approved By: National Society, State Society or Chapter (based on presenting authority)

Description: The medal is in bronze and is similar in design to the Good Citizenship Medal but is inscribed, "Heroism." It is worn suspended from a chest ribbon of the SAR colors. The medal is accompanied by an enameled bar, suitable for wear on uniform, and a certificate for engrossing. No miniature medal is available.

Summary: It recognizes outstanding bravery and self-sacrifice in the face

of imminent danger, i.e., acts which involve great personal courage and risk to the recipient. It is intended primarily for acts by civilians not in uniform but does not exclude police, firemen, and SAR members. It is not intended to recognize acts that would have been covered by armed forces medals for valor. The medal may also be presented posthumously.

Subsequent Presentation Authorized: An individual may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

*Publication*: The names of all recipients are published annually. Each awarding chapter and state society is requested to forward a short written description of the background and accomplishments of the recipients, together with dates, places and names. These should be submitted to National Headquarters, ATTN: Public Service and Heroism Committee and should arrive no later than June 1 each year. The report format is available on the SAR web site.

## **Outstanding Citizenship Award Lapel Pin**

Precedence: N/A Year Authorized: 1992 Presented By: National Society, State Society, Chapter Approved By: National Society, State Society, Chapter

*Description*: The Outstanding Citizenship Award Lapel Pin is a portrait of a Minuteman with the Sons of the American Revolution encircling the upper half and Outstanding Citizenship Award encircling the lower half.

Summary: A chapter, state society or the National Society may present the lapel pin to deserving students in recognition of high ideals of character and citizenship. The Outstanding Citizenship Certificate may also be given in conjunction with the lapel pin.

# MEDALS AWARDED BY THE NATIONAL SOCIETY, A DISTRICT, A STATE SOCIETY OR A CHAPTER TO A LADY FOR SERVICE TO THE SAR

#### **Martha Washington Medal**

Precedence: 37 Year Authorized: 1971 Presented By: National Society, District, State Society or Chapter. Approved By: NSSAR Executive Committee, District Vice President General, State Society or

Chapter (depending on presenting authority).

Description: The medal is gold in color and bears on the obverse a portrait of Martha Washington within the inscription "SAR Martha Washington Award." It is suspended from a chest ribbon of the SAR colors and is accompanied by a certificate, which should be engrossed and presented with the medal. The medal is available in miniature.

Summary: The Martha Washington Medal may be presented to a woman over 18 years of age in recognition of outstanding service to SAR. A DAR may receive the Martha Washington Medal and the SAR Medal of Appreciation (on separate occasions) if her service warrants it.

Subsequent Presentation Authorized: A lady may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

#### Lydia Darragh Medal

Precedence: 38 Year Authorized: 2013 Presented By: National Society, District, State Society or Chapter Approved By: President General, Vice

President General, State Society President or Chapter

President (depending on conferring authority)

Description: The medal is gold in color and bears on the obverse a colonial woman passing military information to a colonial officer mounted on horseback somewhere on a country road. Around the top edge of the medal will read "LYDIA DARRAGH MEDAL" and at the bottom edge of the medal will read "SONS OF THE AMERICAN REVOLUTION." It is suspended from a chest ribbon of light blue.

Summary: The Lydia Darragh Medal may be awarded by the incumbent President General, Vice President General, State Society President or Chapter President to the lady who has provided significant service to him during his term. The medal will recognize the assistance of the ladies who work behind the scenes supporting SAR programs, but whose service does not meet the requirements for the Martha Washington Medal. It may only be presented once per year at the discretion of the President General, a Vice President General, State Society President or Chapter President. The medal should be presented at the annual society by the outgoing President General, Vice President General, State Society President or Chapter President, and the service citation should be read at the time of presentation.

This Medal is named after Lydia Darragh (1729-1789), who crossed British lines in 1777 during the British occupation of Philadelphia, Pennsylvania, to deliver information to George Washington. As did Lydia Darragh, many ladies have had to courageously adapt to various circumstances in an effort to work side by side with Presidents General and State Society and Chapter Presidents.

Subsequent Presentations: A lady may receive this medal only once from a chapter, a state society or a district, however the National Society (through the incumbent President General) may make multiple presentations of the medal to a lady without referral to any committee.

Special Note Regarding Oak Leaf Clusters: Although a lady may receive

the award multiple times from the National Society, and once from each of a district, a state society or a chapter, only one Darragh Medal is worn. Once a lady has received the Darragh Medal, subsequent awards by additional conferring authorities are represented by oak leaf clusters (regardless of the conferring authority).

Retroactive Effectiveness: Former presidents general, vice presidents general, state society presidents, and chapter presidents who have not made a presentation of this award would be eligible to present the medal to a lady upon the presentation of a letter to the incumbent President General, Vice President General, State Society President or Chapter President describing the assistance provided by the lady.

#### **SAR Medal of Appreciation**

Precedence: 36 Year Authorized: 1960 Presented By: National Society, State Society or Chapter. Approved By: NSSAR Executive Committee, State Society or Chapter (depending on presenting authority).

*Description*: The medal is gold in color and bears on the obverse a relief of Molly Pitcher and is inscribed, "Medal of Appreciation." The medal is suspended from a chest ribbon of the SAR colors.

The medal is accompanied by a certificate, which should be engrossed and presented with the medal. The medal is available in miniature.

Summary: The SAR Medal of Appreciation may be presented to a member of the DAR in good standing in recognition of and in appreciation for outstanding services rendered to the SAR. The award may recognize assistance in forming new SAR chapters, obtaining a specific number of new SAR members or otherwise significantly aiding the SAR programs.

Subsequent Presentation Authorized: A lady may receive this medal multiple times. Presentation and wear of oak leaf clusters shall follow NSSAR policy.

There are many ways for you to stand out from the crowd as a proud and supportive member. These range from wearing the member badge or member rosette pin to being involved in the chapter, state, national, and patriotic community activities. You can start now, today, by volunteering to support one of your chapter's activities or committees, by becoming familiar with the National and State Societies and by attending State Society and National Society meetings and participating in their committees and programs. Membership, even as a new member, entitles you to participate at all levels.

Of particular importance in the websites are the Handbook (National Society), Handbook and Regulations (Missouri Society), and Constitution, By-Laws and Operations Manual (Chapter) that define in detail the objectives, policies, organizational structure, protocols, and programs.

You will also find on the websites: schedules of events and meetings, histories of the organizations, recent developments, important announcements, lists of officers and members, lists of revolutionary war patriots and definitions of youth contests/programs, and submittal deadline dates. The national website also provides the "Store" where you can purchase pins, badges, certificates, stationery, medals, clothing, books, and pamphlets. And where you can contribute to national fundraising programs.

#### Terminology -

**Annual Congress**, sometimes called "Congress," is the annual convention of the National Society hosted by a State Society. State Societies select delegates to attend based on their membership size, but every compatriot is welcome to attend; spouses and family members are also welcome.

**Board of Trustees** manages the business and affairs of the National Society and is the custodian of all National Society property; one Trustee represents each State Society.

**C.A.R.** (always pronounced as letters, C-A-R, never as a one-syllable term) is the acronym for the National Society of the Children of the American Revolution. Compatriot is the official designation of a member of the National Society of the Sons of the American Revolution.

Chapter is the local organization chartered by a State Society to promote growth in membership and interest in the objects of the National Society.

**DAR** (always pronounced as letters, D-A-R, never as a one-syllable term) is the acronym for the National Society of the Daughters of the American Revolution.

**District** is a group of State Societies served by a Vice President General to strengthen the constituent State Societies. Your chapter is in the South-Central District.

General Officer is the term given to the National Society officers elected at the Annual Congress to one-year terms. The **President General** is the Chief Executive Officer of the National Society. Serving with him, in descending rank, are the Secretary General, Treasurer General, Chancellor General, Genealogist General, Registrar General, Historian General, Librarian General, Surgeon General, and Chaplain General. A Vice President General is nominated by each District (see below) and elected at Congress.

**Ladies' Auxiliary** aids the SAR at Chapter, State, and National levels. Membership is open to ladies who are related by marriage or bloodline to NSSAR Members in good standing.

Leadership Meeting is each fall and spring in Louisville, KY, at which national committees meet to make recommendations, and the Board of Trustees manages the business and affairs of the National Society.

Membership categories are Regular Member or Regular Life Member the age of 18 years and older, Junior Member under the age of 18 years, and Memorial Membership for a deceased male of the same family as current members.

**SAR** (always pronounced as letters, S-A-R, never as a one-syllable term) is the acronym for the National Society of the Sons of the American Revolution.

**SAR Color Guard** is composed of the compatriots who attend NSSAR meetings and events properly uniformed as either Continental Soldiers or Militiamen or attired as Revolutionary-era clergymen.

**NSSAR Education Center** and Museum are collocated at 809 West Main, Louisville, KY. NSSAR is active in education and raising funds to complete the Museum.

**NSSAR Member Badge** is worn by a compatriot at NSSAR functions and when representing the NSSAR. It is a Maltese cross of four arms and eight points with a bust of George Washington at its center and available from the NSSAR Store at https://store.sar.org/product/member-badge

**NSSAR Rosette** is worn by a compatriot, at his discretion, on the left lapel of his jacket, but is not worn simultaneously with the NSSAR Member Badge. Purchase it from the NSSAR Store at www.store.sar.org/product/member-rosette.

**State Society** is chartered by the National Society in any State or Territory, including any foreign country, in which a Society does not exist. You are a member of the Missouri Society Son of the American Revolution, MOSSAR

**Trustee** is the member nominated by his State Society to serve a one-year term at the national level. He is elected at the Annual Congress to serve on the Board of Trustees. Also elected to the Board of Trustees are General Officers, Executive Committee Members, and former Presidents General.

#### NSSAR – WHO WE ARE

**History:** The NSSAR grew out of a few patriotic organizations that formed during and shortly following the centennial celebration of the United States in the 1870s



and 1880s. Originally organized on April 30, 1889, in Washington D.C., the founding members chose this date because it was the 100th anniversary of the inauguration George of Washington as the first President. Chartered by an Act of the U.S. Congress on June 9, 1906, and signed into existence by President Theodore Roosevelt, a NSSAR member, charter authorizes the granting of charters to state societies and through them to local chapters. Another important date is April 30, 1890, when the first National Congress took place in Louisville, Kentucky. Volume VII of the NSSAR Handbook provides a more detailed history of the NSSAR.

**Objectives:** "The objectives of this Society are stated in the Handbook Volume I, Constitution and Article II, Objectives: and declared to be patriotic, historical, and educational, and shall include those intended or designed to:

- perpetuate the memory of those patriots who, by their services or sacrifices during the war of the American Revolution, achieved the independence of the American people.
- unite and promote fellowship among their descendants; to inspire them and the community-at-large with more profound reverence for the principles of the government founded by our forefathers.
- encourage historical research about the American Revolution; to acquire and preserve the records of the individual services of the patriots of the war, as well as documents, relics, and landmarks.
- mark the scenes of the Revolution by appropriate memorials; to celebrate the anniversaries of the prominent events of the war and the Revolutionary period; to foster true patriotism.
- maintain and extend the institutions of American freedom and to carry out the purposes expressed in the preamble of the Constitution of our country and the injunctions of Washington in his farewell address to the American people."
- For consistency of purpose, most state societies and chapters restate these objectives in their organizational documents (constitutions, by-laws, regulations, and manuals).

**Handbook:** The eight-volume handbook of the NSSAR contains the official policies, procedures, and protocol for the National Society. It provides official guidance for the National Society's operation, programs, and activities. The policies contained in the Handbook are established by the: (1) Annual Congress, (2) Board of Trustees, (3) Executive Committee, (4) National Headquarters staff, and (5) Standing, Special Advisory and Program Committees. The Volumes are:

#### Headquarters & Library:



The NSSAR headquarters is located at 809 W. Main Street Louisville, KY 40202. The website address is: www.sar.org.

The Executive Director of the National Society Headquarters and headquarters staff are paid employees. They carry out the day-to-day operation of the Society. The NSSAR Library, NSSAR Compatriot Application Archives, NSSAR Merchandise Store, and NSSAR Museum are in the headquarters building. Headquarters also staffs Finance, Education, and Genealogy activities. Meeting facilities and classrooms are also available for education.


Any compatriot member may visit the headquarters and use the library for research and view the museum at no charge.

Be sure to have your national membership number for access.

**Non-Profit:** NSSAR is a tax-exempt non-profit organization per IRS 501 (c)(3). This same status, under the umbrella of the National Society, is provided to each state society and its chapters, and each must file annual exemption notifications to the IRS.

**Apolitical:** NSSAR is a non-political organization. Chapters and state societies must never endorse or recommend any candidate for public office, nor can meetings include the discussion of the merits or demerits of such candidates. However, the benefit of any general question involving the social, economic, moral, or physical welfare of the people may be fairly and intelligently studied and discussed at a meeting. NSSAR may take a position on any bill or measure which may be submitted to a vote of the elected representatives of the people or a vote of the people.

**Organization** Here is a very simplified organization structure of the Society. It is not a typical business structure.



The horizontal connectors on the right side emphasize the opportunity for individual compatriots to participate and interact with other compatriots, committees, and officers at all levels of the organization. Participation occurs primarily through attendance by compatriots at two Leadership meetings held in the fall and spring of the year and at the National Congress in the summer.

The President General called the PG is the official head of the organization. He along with the Vice-president Generals, and the Executive Officers: Secretary General, Treasurer General, Chancellor General, Genealogist, General Registrar, General Historian General, Librarian General, Surgeon General, Chaplin General, and National Trustees, are all elected officials of the National Society. The election of the officers occurs at the National Congress held each July. All elected officers serve without compensation.

Following Congress, candidates for the following year declare their candidacy. The candidates seek endorsements from the State Societies and Districts during the year. At Leadership meeting in February, the Nominating Committee selects a slate of officers. Each position has one officer chosen. Nominations can also come from the floor at Congress.

The Standing Committee Chairmen, official members of the committees, and an Inspector General are all appointed by the President General. All these appointed committee members are compatriots from chapters and state societies and serve without compensation.

Appendix A, "National and State SAR Officers" lists the current National and State SAR Officers.

**Societies:** Societies exist in all states (North and South Dakota are combined), France, Spain, and Germany. There are 13 Districts in the U.S., one in Europe and

one that covers other International locations. A US District has three or four states. Each District has a President, also called a Vice President General (VPG), in the National Society who reports to the President General (PG).

**Seal, Insignia, & Standard:** Bylaw No. 26 states that the seal of the Society shall be two and three-eighths (2-3/8) inches in diameter, charged with the figure of a



Minuteman grasping a musket in his right hand, surrounded by a constellation of thirteen stars who shall be depicted in the habit of a husbandman of the period of the American Revolution, and as in the act of deserting the plough for the service of his country; the whole encircled by a band three-eighths (3/8) of an inch wide, within which shall appear the legend, "The National Society of the Sons of the American Revolution, organized April 30, 1889."

Bylaw No. 27 states that the insignia of the Society shall comprise (1) a cross surmounted by an eagle in gold, (2) a rosette.



Bylaw No. 27, Section 1. The cross shall be gold in color, with four arms covered with white enamel and eight gold points, the same size as a Chevalier's Cross of the Legion of Honor of France, with a gold medallion in the center, bearing on the obverse a bust of Washington in profile, and on the reverse, the figure of a Minuteman, surrounded by a ribbon enameled in blue, with the

NSSAR Motto, "Libertas et Patria," (Liberty and Country) on the obverse, and the legend, "Sons of the American Revolution," on the reverse, both in letters of gold. The cross shall be surmounted by an eagle in gold, and the whole decoration suspended from a ring of gold by a ribbon of a blue or deep blue, flanked by buff and white stripes, and may be worn by any member of the Society on ceremonial occasions only, and shall be carried on the left breast or at the collar by active or Past General Officers of the National Society and present or Past National Trustees (the President General shall wear the distinctive badge of his office) or by the President, active or Past, of a State Society and by the President, active or past, of a local Chapter.

<u>Bylaw No 27, Section 2</u>, defines the recognized emblem of the Society is a rosette, seven-sixteenths (7/16) inch in diameter, displaying the colors of the Society, blue,



white, and buff. Every member of the Society is privileged to wear the rosette on all occasions when it would be in good form to do so. On a business suit, the emblem is worn on the left lapel. In those areas of the world in which suit jackets are not required for regular business or Society meetings, the emblem may be worn on the left shirt pocket or the collar. Do not wear

the emblem on formal clothing.

As a member, you can wear the Member Rosette and the Member Badge (available in the NSSAR Shop).

Bylaw No. 28 defines the Society Official Standard as a flag consisting of three equal vertical bars, blue, white, and buff, the blue bar at the hoist.

Upon the center or white bar is the insignia of the Society and the name "The National Society of the Sons of the American Revolution."

The NSSAR provides numerous Badges and Pins to be worn by members. For a complete listing of Badges and Pins and protocols of when and how to wear them consult Volume IV of the Handbook.

**Medals:** The NSSAR provides its members with the opportunity to receive numerous medals and certificates that can be purchased or awarded for various contributions to the NSSAR and its programs at National, State, and Chapter levels. Awards and medals are also available to members and non-members who have completed military, community, or government service outside the NSSAR.

Volume V of the manual provides a complete listing of medals and certificates, the requirements for acquiring or being awarded medals, pins and certificates, and protocol for wearing them.

A summary of medals and certificates that are typically earned by a new member is listed in Appendix B, "Beginning Medals and Certificates".

**Pledge:** The **NSSAR Pledge** should be recited, without modification, as follows:

"We descendants of the heroes of the American Revolution who, by their sacrifices, established the United States of America, reaffirm our faith in the principles of liberty and our Constitutional Republic and solemnly pledge ourselves to defend them against every foe."

The hands should be at the side for the NSSAR Pledge or left hand at the side and the right hand holding a written copy of the Pledge. The hand over the heart should be reserved for the United States Flag – advancing of the colors, the Pledge of Allegiance, the National Anthem, and the retiring of the colors. Many members, especially new members, read the pledge.

The NSSAR Pledge is not a pledge to the organization, but to liberty and our constitutional republic. Nonmembers who wish to make this pledge should be permitted and even encouraged to do so. Those who do not should stand respectfully with their hands at their sides.

The **NSSAR Recessional** should be recited, without modification, as follows:

"Until we meet again. Let us remember our obligations to our forefathers, who gave us our Constitution, the Bill of Rights, an independent Supreme Court, and a Nation of Free Men."

The hands should be at the side for the NSSAR Recessional, or left hand at the side and the right hand holding a written copy of the Recessional. Again, do not hold the right hand over the heart.

**Dues:** The chapters collect annual dues from regular and junior members and forward them to the State Registrar or Treasurer during the last four months of each year. This amount may include State and Chapter dues.

As of 2019, the National dues are \$35 for adult members and \$5 for junior members.

New members whose approval date is September 1 or after do not pay dues for the following year.

A *National Life Membership* option is available but does not cover state or chapter dues.

**Fund Raising:** There are several funds within NSSAR that members may contribute to that are tax-exempt. The more prominent ones are:

- o **Foundation:** Created in 2000 to build the library and museum. A separate board controls this fund.
- o **Center for the Advancement of American History (CAAH):** This fund helps future generations learn the blessings of being an American. It includes areas such as the Genealogical Research Library and outreach programs.
- George Washington Endowment Fund (GWEF): This fund uses only 80% of the interest earned to support underfunded programs of NSSAR.
- o **Other programs having funds:** The Friends of the Library. The Youth Education programs. Eagle Scout Essay. Rumbaugh Oration. Knight Essay. ROTC/JROTC Essay and other educational programs.

**Communication:** The NSSAR will send you a quarterly copy of the NSSAR Magazine. Your annual dues cover the cost.

The National web site <u>www.SAR.org</u> has a link to all things NSSAR, including the By-Laws, the NSSAR Handbook, and merchandise.

#### THE SOUTH-CENTRAL DISTRICT

The National Society is divided into 13 Districts. Each district has a President called the Vice President General or VPG. Each VPG has three to five states in his District and works directly with the State Presidents in promoting the PG's Program.

The Missouri, along with the Kansas, Oklahoma, Arkansas, and Texas Societies, make up the South-Central District.

**Meeting and Events**: The South-Central District holds its annual meeting the 3rd Saturday of August. The meetings are hosted by different states within the district from year-to-year. A highlight of the event is meeting the candidates for election to national offices the following July at the national Congress.

#### THE MISSOURI STATE SOCIETY

**History:** The Missouri Society Sons of the American Revolution was chartered April 23, 1889. Josiah Fogg of St. Louis Missouri served as the first state President of the Missouri Society. Gaius Paddock was the first delegate to the national meeting held in New York. It was at that meeting on April 30, 1889, that the national society was formed.

The first chapter in the state was formed April 1896 in Kansas City. The first St. Louis chapter formed in 1965. Ozarks-Hougendoubler chapter was formed in Springfield in 1966 but some years later suspended operations, as did the first Kansas City and St. Louis chapters.

The Sgt. Ariel Nims Number is now the oldest chapter, it was formed on May 29, 1976. There are 15 chapters in Missouri as of August 2020. The William C. Corum Chapter in Liberty was formed on September 26, 1981. Missouri's chapters, at present are:

The purpose of our organization is to carry on and conduct educational, patriotic, historical, and civic activities, to perpetuate the memory of the men and women who served and sacrifice during the War of the American Revolution, to encourage educational programs and promote historical research in the American Revolution, and to foster patriotism.

**Non-Profit/Charitable:** The donation is a Non-Profit Organization, Charitable Organization, and Missouri Business. The MOSSAR is an IRS 501 (c) (3) organization under the umbrella of the National Society. It is registered in the state of Missouri with the Secretary of State as a non-profit Missouri business, and it is registered with the Missouri Attorney General's office as a Charitable Organization. It operates under its own Constitution and By-Laws in the Missouri Handbook on the MOSSAR website.

**Officers**: The Missouri Society Officers are elected by members attending the Missouri Society annual meeting held the last Saturday of April each year. The Nominating Committee presents a slate of officers and nominations from the floor may be made. Any Missouri member may attend and vote. Elected officers are: President, Executive Vice President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, Genealogist, Registrar, Historian, Chaplain, Chancellor, Trustee and Alternate Trustee. The President chooses all other officers and Chairmen of standing committees. All officers serve without compensation.

Appendix A, "National and State SAR Officers" provides a list of current National and State SAR Officers.

To review the offices and associated responsibilities, see the Missouri Handbook on the MOSSAR website. To review the names and addresses of current officers,

go to the "Membership" tab of the Missouri website, and click on Missouri Society Links and click on Society Officers.

**Board of Directors**: The affairs of the Society are managed by the Board of Directors within the meaning of the Missouri Nonprofit Corporation Law.

The BOD consists of the following persons, occupying certain positions within the Missouri Society, who constitute the entire membership of the Board of Directors:

- The elected Missouri Society Officers
- The Missouri National Trustee and in his absence the Alternate National Trustee.
- Chapter Presidents
- Past Missouri Society Presidents (Honorary Vice Presidents).
- Past Presidents General of the National Society who are members of the Missouri Society (Honorary Vice Presidents).

The BOD acts on behalf of the membership.

**Standing Committees:** There are several standing committees established to assist in the administration of the Missouri Society; or exist to support national and state programs. A complete list of these committees and their chairmen is provided in the MOSSAR web site.

These committees need your help, and you can volunteer to be part of the state leadership.

**Meetings**: The Missouri Society holds at least four meetings each year:

- The BOD meetings are normally held quarterly at 10am on the last Saturday of the following months, January, July, and October. However, starting in 2020, the norm has been for the BOD to meet monthly.
- Annual State Convention and BOD meeting is the last Saturday in April at a location determined by the host Chapter. All members of a State Chapter may attend and vote on any resolutions coming before the membership and election of officers. All members and their spouses are encouraged to attend the State Convention.

**Dues**: The current annual State dues of the Missouri Society are \$16.00 for regular members. Junior members State dues are \$5.00. Dues are collected beginning in September for the following calendar year by chapters and forwarded to the State Treasurer for recording.

**Programs:** The Missouri Society, with the help of its chapters, supports the National Society Programs. Details of these programs can be found on the National Website and in the Missouri Society Handbook found on the MOSSAR

website. Chapters support many of these programs. See the Participation section in the William C. Corum Chapter part of this Workbook following, where several of these programs are presented.

**Color Guard:** The Missouri Society has a very active state color guard. It consists of about 60 members. The State Society and Chapter Color Guards are part of the National Color Guard. Any compatriot that has a militia or continental uniform is considered a volunteer member of the color guard. The Color Guard is one of the ways our SAR and Missouri Society become visible to the public. And it helps to support community programs, by performing at parades, flag postings, school programs, and other events. The color guard acts as true ambassadors for Missouri Society.

**DAR:** The Missouri Society partners with the Daughters of the American Revolution (DAR), by reciprocal attendance at annual state meetings, posting flags, exchanging speakers, and supporting membership recruitment.

**Missouri Auxiliary**: The Missouri Society Auxiliary is open to individuals connected to a member in good standing or a member deceased while in good standing of the Missouri Society. They are always welcome at meetings, and it is a time that they can meet and work on worthwhile projects supporting their programs or Missouri Society programs. Medals and certificates are also available for auxiliary members who participate.

**C.A.R.** The State Society supports the Children of the American Revolution (C.A.R.) Society. We encourage members to work with this organization. Also, we encourage our Junior members to join the C.A.R.

**Insignia & Seal**: The Missouri Society has adopted the outline of State of Missouri with the minute man and thirteen stars. The seal of the Society shall be two and three-eighths (2-3/8) inches in diameter.



**Endowments:** The Missouri Society has two endowments funds that are retained in a separate institution from the current (checking) account and are managed by the Finance Committee and its Investment Subcommittee.

- Patriots Trust Fund-Was established on July 26, 1986 to receive and administer all types of gifts and assets donated to the Missouri Society. The purpose of the fund is to further the objectives of the SAR to include Patriotic, Historical and Educational actives. Funds may be expended for, but not limited to, sponsorship candidates for the Joseph S. Rumbaugh Oration Contest and the Eagle Scout and Scholarship Program at the Sate and Chapter levels. The fund is also used to assisting the Missouri Society in certain events or projects developed at the Chapter and State level approved by the BOD.
- Yohe Public Safety Award Fund-Was established on July 30, 1994 to receive and administer all types of gifts and assets donated to this fund in the name of The Missouri Society of the American Revolution. The purpose of the fund is to further the objectives of the SAR to include Patriotic, Historical and Educational actives. Funds may be expended for, but not limited to, sponsoring awards for Law Enforcement Commendation, Fire Safety Commendation, and Silver Good Citizenship (for service to the State) in a manner consistent to the public good and welfare. The selection criteria shall be that outlined in the Medals and Awards Section of the National Society Official Handbook.

# (This is a sample chapter addendum.) WILLIAM C. CORUM CHAPTER

As the William C. Corum Chapter President, I want to welcome you to our Chapter personally. I hope that you will be an active participant in the many programs that the chapter offers. Don't be shy – Volunteer.

**History:** William Cookskin Corum was born in 1760 in Virginia. His father, John was a native of England, his mother was Nancy Cookskin. He went to North Carolina, where he worked as a trader and teamster, and served in the Revolution from that state as a wagoner in the Commander-in-Chief's Guard from April 1, 1778 through June 4, 1783, by which time he had advanced to the rank of sergeant. He met Barsheba Bloyd in Somerset County, Maryland, married her, and migrated to Green County, Kentucky, where several of their children were born. In 1818 the family migrated to Cooper County, Missouri, and later moved to Clay County. By 1842 lands patented in his and his son's names totaled more than 1300 acres. William died August 5, 1853 and Barsheba died February 1853 both are buried in a family cemetery with 20 marked gravestones and many plain field stones, located west of Liberty behind a modern farmhouse.

The William C. Corum Chapter was organized on September 26, 1981, by Past President General Arthur M. King and prospective SAR Compatriots from Clay County. Several Descendants of William Corum have been members of the chapter, including its first President, Brigadier General and Judge, R. Kenneth Elliot, U.S. Congressman, Ike Skelton and Missouri Society President, Robert J. Corum.

Today, the William C. Corum Chapter is one of the largest chapters in Missouri.

**By-laws:** The William C. Corum Chapter, is organized under a Constitution and set of By-Laws. A copy can be provided upon request made to the chapter Secretary.

**Not for Profit Organization and Charitable Organization:** Under the umbrella of the National Society, The William C. Corum Chapter SAR is an IRS 501 (c) (3) chartered organization. It is registered with the Missouri Attorney General's office as a Charitable Organization. It operates under its own Constitution and By-Laws that can be obtained upon request from the chapter secretary.

**Officers:** The By-Laws establish Chapter Officers. The officers shall be elected by the Chapter members present at a regularly scheduled chapter meeting prior to November of each odd numbered year. The term of all elected officers shall be two years. Number of terms or offices held shall not be limited. Officers will be installed as scheduled by the Executive Committee. Detailed responsibilities of officers can be found in the Chapter By-Laws. A brief description is as follows:

**President** - Responsible for overall chapter programs and meetings

Vice President - Act for President and supports President's agenda.

**Secretary** - Records meeting minutes and participation.

**Treasurer** - Maintains financial records and collects dues.

**Chaplain** - Provides spiritual support for the chapter.

Historian - Maintains a historical file on all chapter activities and publicity.

**Registrar** - Processes membership applications and reinstatements.

**Genealogist** - Assists with genealogy research on applications.

See Appendix C, "William C. Corum Chapter Officers" for a list of current officers.

**Meetings:** Chapter meetings are held on the 2nd Saturday of the month. No meetings are held in the months of July and August. The February meeting is held with all the other SAR and DAR Chapters in the Kansas City area on the Saturday close to George Washington Birthday.

## Appendix B – Beginning Medals and Certificates

The following medals and certificates are typical awards earned within the first three years of being a compatriot. Once the requirements of the medal are approved, the compatriot, National Society, State Society or Chapter purchases the medals. The details are defined in the National Society Official Handbook Volume V, Precedence Section. The compatriot may also work toward other medals or certificates. Those given here are typical. For the complete list of medals, certificates, and their requirements, see Volume V of the Handbook.

Medals awarded by the National Society for service to the NSSAR.

- \* <u>Lafayette Volunteer Service Medal</u>. Awarded for performing 40 hours of volunteer service on assigned NSSAR programs.
- \* Patriot Grave Marking Medal. For planning or participation in the marking of 15 patriot graves.

Medals awarded by a State Society to Compatriots for service to the SAR.

\* Bronze Color Guard Medal. For participation in chapter and state color guard events.

Medals awarded by a Chapter to Compatriots for service to the SAR.

- \* <u>Chapter Medal of Distinguished Service</u>. Presented by chapter president in recognition of the Compatriot's conspicuous service to the Chapter.
- \* <u>Bronze Roger Sherman Medal</u>. Presented by the chapter in recognition of and appreciation of outstanding services rendered to a chapter.

Medals awarded by National or State Society or Chapter for 250th Anniversary of the American Revolution. The recognition program is designed to encourage and recognize those compatriots, chapters and societies that participate in local, state, national and international events which publicly educate, and recognize, honor, and celebrate the events and heroes of the period surrounding the American Revolution.

- \* <u>Bronze Medal</u> is presented to a person who has 25 promotion points certified by his chapter, state, district of national society.
- \* <u>Silver Medal</u> is presented to a person who has 60 promotion points certified by his chapter, state, district of national society.
- \* <u>Gold Medal</u> is presented to a person who has 150 promotion points certified by his chapter, state, district of national society.

Medals awarded by National or State Society or Chapter for Military Service and Service to Veterans

- \* <u>War Service Medal</u>. For compatriots who complete an application and provide documentation (DD214) verifying military service in a branch of the US Military in a hazardous or war zone.
- \* <u>Military Service Medal</u>. For compatriots who complete an application and provide documentation (DD214) of active-duty service in a branch of the US Military.
- \* <u>Service to Veterans Medal</u>. For completion of the application on providing various types of service to veterans or veterans organizations.

Certificate awards Presented for Service to the SAR

- \* <u>Distinguished Service Certificate</u>. To recognize outstanding personal service exemplifying the finest of American ideals
- \* <u>Certificate of Appreciation</u>. To acknowledge outstanding support given to the Sons of the American Revolution.

\* <u>U.S. Flag Retirement Certificate</u>. Presented for participation in the collection and destruction of worn, soiled, or otherwise unserviceable United States Flags.

Pins awarded for Donations to National Programs

- \* A <u>Friends of the Library</u> Membership Lapel Pin can be awarded for a nominal \$25 gift to the Friends of the Library. Annual renewal of membership is appreciated. Four additional levels of contributions are available.
- \* <u>George Washington Endowment Fund Fellow</u> Lapel Pin can be obtained for a gift of \$1000 to the George Washington Endowment Fund.
